### Executive Summary

Authorizing the Manager of Procurement Services to execute two contracts in the amount of \$500,000.00 each with qualified community-based organizations Arts Tech and Upper Room KC from previously appropriated funds to design, implement, and operate youth summer and after-school programming designed to reduce youth violence, promote positive social behaviors, and also integrates academic, recreational, and therapeutic activities and will prioritize youth who are justice-involved, disconnected from school, or exposed to violence and trauma; authorizing a total expenditure of \$1,000,000.00 to satisfy the cost of the contracts; and recognizing this ordinance as having an accelerated effective date.

### Discussion

Arts Tech and Upper Room KC will provide structured after-school and summer programming during high risk hours in a safe, supervised environment. Throughout all programming there will be integrated evidence-based and evidence-informed violence prevention strategies. Opportunities will be provided that will build leadership, academic engagement, and personal responsibility. This program will also be able to strengthen collaboration with families, schools, and community partners.
