<p><b>Reason for Legislation</b></p> <p>Directing the City Manager to implement a Healthier Vending Policy for vending machines at City facilities.</p>															
<p><b>Discussion</b> <i>(including relationship to other Council actions)</i></p> <p>The City recognizes the role that healthier eating plays in contributing to our overall health. Many convenience food and beverage items contain large quantities of sugar, sodium, saturated fats and calories that negatively contribute to health issues of employees and visitors such as diabetes, cardiovascular disease, obesity and hypertension. As an employer, the City believes it has an obligation to create a healthier workforce while concurrently controlling healthcare costs.</p> <p>This resolution directs the City Manager to implement a Healthier Vending Policy based on the “KCMO Healthier Vending Initiative” prepared by the Health Department and presented to the Healthcare Trust.
