Details**Reason for Contract**

Approving Amendment No. 2 with Black and Veatch Corporation for Blue River WWTP Effluent Disinfection Design Services; and authorizing the Director of Water Services to expend approximately \$1,489,000.00.

Discussion**Project Justification**

These projects are being done in order to meet the Missouri Department of Natural Resources mandated regulations for disinfection at the Blue River Wastewater Treatment Plant by December 2013. This project is part of the Environmental Protection Agency's Consent Decree.

Project Description

The design professional services project's scope of services consists of the following:

- Provide design of a disinfection facility at the site of the existing Blue River Wastewater Treatment Plant to meet the new MDNR guidelines for disinfection;
- Work will include a preliminary design and detailed design services to prepare construction documents, bidding services, construction phase services, and closeout services.

This project is located in City Council District 4.

Contract Summary

The City Council approved Ordinance No. 100642 on August 19, 2010 approving a \$5,251,000.00 contract with Black and Veatch Corporation for the Blue River WWTP Effluent Disinfection Design Services project and Ordinance No. 120133 on February 23, 2012 approving an Amendment 1

Amendment No. 2 is needed to add construction phase and construction observation services to the project.
