## MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION STP-URBAN PROGRAM SUPPLEMENTAL AGREEMENT

THIS SUPPLEMENTAL AGREEMENT is entered into by the Missouri Highways and Transportation Commission (hereinafter, "Commission") and the City of Kansas City (hereinafter, "City").

## WITNESSETH:

WHEREAS, on July 7, 2015, the Commission and the City previously entered into a Surface Transportation Program (STP) Agreement as to public improvements designated as STP 3377(408), for the purchase of Right-of-Way along Front Street from I-35 to Universal, (hereinafter, "Original Agreement"); and

WHEREAS, the Commission and the City now desire to revise the Original Agreement.

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations contained herein, the parties agree as follows:

- (1) <u>REVISION</u>: Paragraph (1) <u>PURPOSE</u> of the Original Agreement is removed and replaced with the following:
- (1) <u>PURPOSE</u>: The purpose of this Agreement is to grant the use of STP funds to the City. The improvement contemplated by this Agreement and designated as Project STP-3377 (408) Front Street from Chouteau Trafficway to Universal involves:

The use of Federal Funds for the reconstruction of the existing road and added two through lanes with a center turn lane along Front Street from Chouteau Trafficway to Universal.

The City shall be responsible for all aspects of the construction of the improvement.

- (2) <u>REVISION</u>: Paragraph (2) <u>LOCATION</u> of the Original Agreement is removed and replaced with the following:
- (2) <u>LOCATION</u>: The contemplated improvement designated as Project STP-3377 (408) by the Commission is within the city limits of Kansas City, Missouri. The general location of the improvement is shown on an attachment hereto marked "Exhibit A" and incorporated herein by reference. More specific descriptions are as follows:

Front Street from the Chouteau Trafficway to Universal Avenue in Jackson County, Kansas City, Missouri.

- (3) <u>REVISION</u>: Sub-Paragraph (A) following Paragraph (12) <u>REIMBURSEMENT</u> of the Original Agreement is removed and replaced with the following:
- (A) Any federal funds for project activities shall only be available for reimbursement of eligible costs which have been incurred by City. Any costs incurred by City prior to authorization from FHWA and notification to proceed from the Commission are **not** reimbursable costs. The federal share for this project will be **80 percent** not to exceed **\$2,969,222.00**. The \$2,969,222.00 is the remaining unused funds from the original agreement. The calculated federal share for seeking federal reimbursement of participating costs for the herein improvements will be determined by dividing the total federal funds applied to the project by the total participating costs. Any costs for the herein improvements which exceed any federal reimbursement or are not eligible for federal reimbursement shall be the sole responsibility of City. The Commission shall not be responsible for any costs associated with the herein improvement unless specifically identified in this Agreement or subsequent written amendments.
- (4) <u>ORIGINAL AGREEMENT</u>: Except as otherwise modified, amended, or supplemented by this Supplemental Agreement, the Original Agreement and all previous Supplemental Agreements between the parties shall remain in full force and effect.
