COMMITTEE SUBSTITUTE TO ORIGINAL ORDINANCE

COMMITTEE SUBSTITUTE FOR ORDINANCE NO. 160524

Authorizing the Director of Public Works to enter into a Municipal Agreement with the Missouri Highways and Transportation Commission related to the replacement of the Grand Boulevard Bridge over I-670; appropriating \$1,200,000.00 from the unappropriated Capital Improvements Fund balance; authorizing the Director of Public Works to expend ~~\$600~~1,200,000.00 for the project; designating requisitioning authority; and recognizing this ordinance as having an accelerated effective date.-

WHEREAS, the Missouri Highways and Transportation Commission (“Commission”) is completing an emergency replacement of the Grand Boulevard Bridge over I-670; and

WHEREAS; the bridge is and will be owned and maintained by the Commission; and

WHEREAS, the City desires additional bridge enhancements and roadway features beyond what the Commission requires and is working in partnership with the Commission for the City to provide funding for the construction of these enhancements and features; and

WHEREAS, the City will be responsible for the maintenance of these enhancements once they are constructed; and

WHEREAS, the City and the Commission would like to allow the bidding of the project in August 2016 so that the bridge replacement can be completed this year; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the Director of Public Works is hereby authorized to execute a Municipal Agreement with the Missouri Highways and Transportation Commission ~~to provide them up to \$600,000.00~~ for the construction of bridge enhancements and roadway features on the Grand Boulevard Bridge over I-670. A copy of this agreement, in substantial form, is attached hereto and is hereby approved.

Section 2. That \$1,200,000.00 is appropriated from the Unappropriated Fund Balance of the Capital Improvements Fund to the following account:

Section 3. - That the Director of Public Works is designated the requisitioning authority for Account ~~no~~No. 17-3090-898034.

Section 4. That this ordinance, relating to the design, repair, maintenance or construction of a public improvement, is recognized as an ordinance with an accelerated-effective date as provided by Section 503(a)(3)(D) of the City Charter and shall take effect in accordance with that section.

I hereby certify that there is a balance, otherwise unencumbered, to the credit of the appropriation to which the foregoing expenditure is to be charged, and a cash balance, otherwise unencumbered, in the treasury, to the credit of the fund from which payment is to be made, each sufficient to meet the obligation hereby incurred.
