Executive Summary

Authorizing a \$751,978.00 design professional services Amendment No. 2 with HDR Engineering, Inc. for the Green Infrastructure Project 1-1: Mill Creek Park project for a total contract amount of \$1,576,978.00; and recognizing this ordinance as having an accelerated effective date.

Discussion

Reason for Contract

In 2010, the City of Kansas City, Missouri entered into a Consent Decree with the United States Environmental Protection Agency (EPA) to reduce the volume and frequency of overflows from the City's sewer system. The City's Smart Sewer Program is currently in year 14 of a 30-year implementation period. The purpose of this project is to contribute to a sustainable Kansas City by implementing Green Infrastructure to reduce typical year Combined Sewer Overflows (CSO) in the Brush Creek Basin. This project will improve water quality, reduce heat-island effect, and will add resiliency to the community's sewer system through integration of green infrastructure.

Contract Description

The scope of work to be provided under the design professional contract includes final design of the green infrastructure project consisting of landscaped stormwater storage basins to control the first 1.4-inches of rainfall runoff from approximately 61 acres along Main Street, from 40th Street to 45th Street. Landscaping of the stormwater storage basins includes tall native prairie grasses and perimeter plantings will include tree varieties selected in coordination with KC Parks and the Mill Creek Park Association. Also included in the project is design of storm sewers to deliver stormwater to the storage basins, pretreatment devices to remove trash and sediment from the stormwater before entering the basins, perimeter walkways and maintenance paths around the stormwater storage basins, lighting of the walkways to park standards, a limited irrigation system to aid establishment of the tallgrass plantings, and relocation of a water transmission main.

Original Solicitation

The Green Infrastructure Project 1-1: Mill Creek Park was advertised in accordance with the City's requirements on August 21, 2020, and proposals were received on September 28, 2020, with six (6) Design Firms responding.

MBE/WBE Goals

CREO KC established goals of 15% MBE and 10% WBE on this design professional services project on August 8, 2020.

Subcontracting goals will be met with this amendment.

Consultant Selection/Subcontracting Participation

HDR Engineering, Inc. was selected for this project in accordance with Code of Ordinance Section 3-31(b)(1), Citywide selection with subcontracting participation of 15% MBE and 10% WBE.

<u>Design Professional Services Contract Description</u>

City Council passed Ordinance No. 210341 on April 29, 2021, which authorized a \$750,000.00 design professional services contract with HDR Engineering, Inc. for conceptual, preliminary, and final design of the Green Infrastructure Project 1-1: Mill Creek Park.

Design Professional Services Contract Amendment No. 1 Description

The City executed a \$75,000.00 Amendment No. 1 on May 3, 2023, which authorized additional final design services not included in the original scope of work.

Design Professional Services Contract Amendment No. 2 Description

The proposed \$751,978.00 Amendment No. 2 will provide for value engineering services and additional design and bid phase services not included in the original scope of work. Construction bids were solicited for the original design in March of 2024. One bid was received that was significantly above the capital improvement budget for the project. The value engineering work included in Amendment No. 2 will provide a review of the original design with recommendations for changes to reduce overall costs while maintaining the original intent and benefits of the project. The Amendment also allows for design phase services to modify the design based on the recommendations of the value engineering effort and to provide additional bid phase services to re-bid the project.

This amendment will extend the design contract 198 calendar days.

Prior Legislation

City Council passed Ordinance No. 210341 on April 29, 2021, authorizing a \$750,000.00 design professional services Contract Number 1611 with HDR Engineering, Inc. for conceptual, preliminary, and final design of the Green Infrastructure Project 1-1: Mill Creek Park project.

Service Level Impacts

This project will reduce the amount of stormwater getting into the City's combined sewer system reducing the occurrence of wet-weather overflows within the City's existing combined sewer system, thereby protecting public health and the environment.
