<p><b>Details</b></p> <p><b>Reason for Legislation</b></p> <p>To authorize fire department service agreements with four (4) Northland communities.</p> <p><b>Discussion</b></p> <p>The Fire Department has historically contracted with three Northland communities to provide emergency response to:</p> <ul style="list-style-type: none"> <li>* Fires of all types</li> <li>* Emergency medical incidents</li> <li>* Rescue events such as auto extrication</li> <li>* Hazardous materials calls for service such as carbon monoxide detector investigations, chemical spills and etc.</li> <li>* Disasters such as tornado strikes and etc.</li> <li>* Ambulance service is not included in these agreements.</li> </ul> <p>In addition, the Fire Department contracts with the City of Riverside to provide advanced life support ambulance services ; other fire department services are not included in this agreement.</p> <p>This ordinance authorizes the Fire Chief to continue those contract agreements.</p>
