REGULATION NUMBERS 64724 THROUGH 64737 INSTALLATIONS

TO WHOM IT MAY CONCERN:

Pursuant to the authority granted in paragraph (b) of Section 70-38 of the “Code of General Ordinances of Kansas City, Missouri” and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

Turns are prohibited, as indicated, at the following location(s) (in the direction bound as indicated) and shall be added to the list as contained in **Section 70-457**:

| <u>Regulation Number</u> | <u>Location</u> | <u>Turn Restriction</u> |

| 64624 | NE 94 th Street at 530 NE 94 th Street, Eastbound | No Left Turn |

Stopping, Standing and/or Parking shall be prohibited (as indicated) on the following street(s) and shall be added to the list as contained in **Section 70-530**:

| 64725 | 39 th Street, south side, from a point 50 feet west of Terrace Street to Wyoming Street | No Parking 7:00 AM to 9:00 PM Monday through Friday |
| 64726 | 39 th Street, south side, from Terrace Street then west 50 feet | No Parking Anytime |
| 64727 | Charlotte Street, east side, from 8 th Street to 9 th Street | No Parking Anytime |
| 64728 | Charlotte Street, east side, from 9 th Street to 10 th Street | No Parking Anytime |

Parking for longer than the **Time Limit**, as indicated below, during the hours and/or days indicated shall be prohibited. The time limit and effective hours and/or days shall be added to the list as contained in **Section 70-531**:

| 64731 | Charlotte Street, west side, from 9 th Street to 10 th Street | Ten Hour Parking 6:00 AM to 8:00 PM Monday through Friday |
| 64732 | Grand Boulevard, west side, from a point 50 feet north of 19 th Street then north 124 feet | Three Hour Parking 7:00 AM to 6:00 PM Monday through Friday |
| 64733 | Grand Boulevard, west side, from a point 140 feet south of 19 th Street then south 105 feet | Three Hour Parking 7:00 AM to 6:00 PM Monday through Friday |
| 64734 | Holmes Street, west side, from a point 265 feet north of 26 th Street to a point 70 feet south of 25 th Street | One Hour Parking 7:00 AM to 6:00 PM Monday through Friday |

Reserved parking for **Physically Disabled Persons** is hereby established, as indicated below, and shall be added to the lists as contained in **Sections 70-534** and **70-535**:

A Public Carrier Stand is designated at the following location(s), and shall be added to the list as contained in **Section 70-566**:

| 64737 | Grand Boulevard, west side, from a point 60 feet south of 19 th Street then south 80 feet | No Parking Bus Stand |
