Reason for Legislation

Authorizing the Director of Neighborhood and Housing Services accept and enter into grant agreements with the U. S. Housing and Urban Development for the 2011 Supportive Housing Program and enter into contracts with various nonprofits for delivery of services to homeless families and individuals in the Kansas City, Missouri area; and estimating additional revenues and appropriations in the amount of \$5,411.00 in the General Fund.

Discussion

(Including relationship to other Council actions)

Is it good for the children? Yes...through the provision of housing, employment and medical prescription services.

How will this contribute to a sustainable Kansas City?

The City originally applied for this homeless assistance grant in 1994 and received its first award in 1995. Since that time, we have successfully continued to receive continuum of care which totals \$715,582. The City of Kansas City, in partnership with the CoC, converted 2 projects operated by reStart inc and United Services Community Action Agency, from a supportive services only (SSO) and transitional housing projects, to a permanent housing project in accordance with the 2011 Super Notice of Funding Availability guidance, respectively.

Community LINC- shall provide transitional living for 12 homeless families (\$122,893.00)

Greater Kansas City Housing Information Center- housing counseling services for homeless persons (\$24,265)
