

ORDINANCE NO. 200801

Estimating revenue in the amount of \$130,000.00 in the Capital Improvements Sales Tax Fund; appropriating that amount to the North Troost Trail Improvements in the same fund; and designating requisitioning authority.

WHEREAS, the North Oak Tax Increment Financing Plan was subsequently amended several times by the Council's passage of a series of Ordinances (the North Oak Tax Increment Financing Plan, as amended, is hereafter referred to as the "Plan"); and

WHEREAS, the Plan provides, among other things, for the design and construction of roadways and other public infrastructure within and adjacent to the Redevelopment Area, including the design and construction of North Troost Trail between N.E. Englewood Road and N.E. Vivion Road ("Trail Project"), the acquisition and renovation of the former YMCA building located at 1101 N.E. 47th Street, Kansas City, Clay County, Missouri (the "YMCA Stabilization Project"); and

WHEREAS, on August 7, 2020, the City Council, by Ordinance No. 190925, approved the Eleventh Amendment to the Plan, which provides, in part, for an increase of One Hundred Thirty Thousand Dollars (\$130,000.00) in reimbursable Redevelopment Projects related to the North Troost Trail Project (the "Eleventh Amendment Modifications"); and

WHEREAS, in the amendment, funding was identified for the construction of the last piece of trail between N.E. 49th St and N.E. Vivion Road trail along North Troost Avenue, to include 10' wide concrete trail, storm drainage pipe under N. Troost, crosswalk and flashing beacon pedestrian sign; and

WHEREAS, the Commission and the City wish to complete the project cooperatively and in partnership; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That revenue in the amount of \$130,000.00 is hereby estimated in the following amount of the Capital Improvements Sales Tax Fund:
