Authorizing and accepting opioid settlements with Sandoz, Inc, Purdue Pharma/Sackler, and the Secondary Distributors (Alvogen, Amneal, Apotex, Hikma, Indivior, Mylan, Sun, and Zydus); and authorizing the City Attorney to settle these claims and further negotiate with the State of Missouri over the City's portion of Purdue Pharma/Sackler Family settlement proceeds pursuant to the MOU executed between the City and the State of Missouri.

Matthew Gigliotti, City Attorney, presented. This ordinance authorizes the city to accept and finalize opioid settlement agreements with several companies, including Sandoz, Inc., Purdue Pharma, and the Sackler Family, as well as secondary distributors (Alvogen, Amneal, Apotex, Hikma, Indivior, Mylan, Sun, and Zydus). It empowers the City Attorney to settle these claims on behalf of Kansas City and to continue negotiations with the State of Missouri regarding the City's share of Purdue/Sackler settlement proceeds under the previously executed state-city Memorandum of Understanding (MOU). Jeff Martin, City Manager's Office, presented. This ordinance authorizes the City to dedicate \$15,080,817.20 in bond funds to the Roy Blunt Luminary Park Project and permits the Finance Director to close project accounts once work is complete, with the City also able to reimburse itself for certain expenses from bond proceeds. It further authorizes the City Manager to enter into a Development Agreement with Port KC, the Downtown Council, and its development corporation, and to approve amendments to existing contracts with HNTB Corporation (\$13.7M), Project First, LLC (\$670K), and JE Dunn/Clarkson Construction (\$713K). The updates specifically modify how specific city policies apply to economic development areas and tax increment financing (TIF) plans, ensuring that the City’s contracting and redevelopment procedures are aligned and consistent with current TIF requirements.

Heather Bray, Finance Department and Nicolas Bosonetto, City Engineer and Bailey Waters, Public Works Department, presented. This ordinance relocates City bond proceeds and sales tax funds by reducing a series of appropriations across multiple General Obligation Bond funds, Special Obligation Bond funds, and the Capital Improvements Sales Tax Fund, and then appropriating \$1,900,000.00 to fund the Broadway Bike Lane project from 31st to 43rd Street. It also reduces \$1,500,000.00 from the Capital Improvements Sales Tax Fund and appropriates that amount to the Southwest Boulevard project (31st to Broadway Study). The ordinance is recognized as having an accelerated effective date to ensure these transportation and infrastructure improvements move forward quickly.
