REGULATION NUMBERS 63280 THROUGH 63291 INSTALLATIONS

TO WHOM IT MAY CONCERN:

Pursuant to the authority granted in paragraph (b) of Section 70-38 of the "Code of General Ordinances of Kansas City, Missouri" and subject to the provisions thereof, traffic regulations are hereby made and adopted as follows:

The following street(s) is (are) designated as a <u>"Through Street(s)"</u> and shall be added to the list as contained in <u>Section 70-335</u>:

Regulation Number	Location	Restriction
63280	22nd Street, from The Paseo to Prospect Avenue	Through Street

All vehicular traffic shall **Stop** before entering the following intersection(s) and shall be added to the list as contained in **Section 70-335**:

Regulation Number	Location	Direction of Restriction
63281	Sycamore Avenue and 52nd Terrace	Northbound and Southbound

<u>Turns</u> are prohibited, as indicated, at the following location(s) (in the direction bound as indicated) and shall be added to the list as contained in <u>Section 70-457</u>:

Regulation Number	Location	Turn Restriction
63283	Northeast Chouteau Trafficway and North Cleveland Avenue	No "U" Turn Southbound

Stopping, Standing and/or Parking shall be prohibited (as indicated) on the following street(s) and shall be added to the list as contained in **Section 70-530**:

Regulation Number	Location	Restriction
63284	North Hampton Road, east side, from a point 2,600 feet north of Northwest Tiffany Park Road then north 50 feet	No Parking Anytime
63285	North Hampton Road, west side, from a point 1,980 feet north of Northwest Tiffany Park Road then north 800 feet	No Parking Anytime
63286	James A. Reed Road, west side, from Bannister Road south to a point 119 feet south of 96th Terrace	No Parking Anytime
63287	James A. Reed Road, west side, from Overhill Road north 145 feet	No Parking Anytime
63288	McGee Street, east side, from a point 432 feet north of Pershing Road then north to 22nd Street	No Parking Anytime

Reserved Parking for <u>Physically Disabled Persons</u> is hereby established, as indicated below, and shall be added to the lists as contained in <u>Sections 70-534 and 70-535</u>:

Regulation Number	Location	Restriction
63289	Armour Boulevard, south side, from a point 42 feet west of Central Street then west 19 feet	Accessible Parking
63290	Wyandotte Street, east side, from a point 90 feet south of 2nd Street then north 13 feet	Accessible Parking

A <u>Loading Zone</u> is designated at the following locations, and shall be added to the list as contained in <u>Section 70-561:</u>

Regulation Number	Location	Restriction
63291	11th Street, south side, from a point 19 feet west of Baltimore Avenue then west 132 feet	No Parking Loading Zone

The locations affected by the above regulations will be marked in accordance with standards prescribed in the "Manual on Uniform Traffic Control Devices for Streets and Highways" and said regulations shall become effective five days after publication in The Daily Record.
