BUDGET MESSAGE

The Linwood Square Shopping Center Community Improvement District ("District") was declared established by Ordinance No.191023 of the City Council of the City of Kansas City, Missouri on December 12, 2019. The District desires to fund, or assist in the funding of, certain services and improvements as allowed by Sections 67.1401 to 67.1571 RSMo.

On May 28, 2020, the District's Board of Directors passed Resolution No. 2020-07 which imposed, upon approval of the qualified voters of the District, a one percent (1%) sales and use tax on retail sales in the District for the life of the district. The sales and use tax collection became effective on January 1, 2022.

The District has adopted a fiscal year beginning May 1 and ending April 30 of each year.

One December 8, 2021 the District's Board of Directors passed Resolution No. 2021-06 which authorized the execution of a reimbursement agreement with Linwood Shopping Center Redevelopment Company LLC.

WHEREAS, effective August 15, 2023, Linwood Shopping Center Redevelopment Company, LLC ("Developer") entered into a Collateral Assignment with UMB Bank, N.A. related to the Developer's rights and interest in District sales and use tax revenue pursuant to its Reimbursement Agreement with the District;

WHEREAS, effective August 17, 2023, the District acknowledged and executed consent to the Collateral Assignment by Resolution 2023-04;

WHEREAS, Developer now desires to enter into a sixth loan modification of the Loan Agreement (which was the subject of the Collateral Agreement consented to by the District in August 2023) with UMB Bank, N.A. ("Modification Agreement"); and

WHEREAS, the Modification Agreement with UMB Bank, N.A., includes the execution of a CID Acknowledgement by the District to consent and agree to the terms and provisions of the Modification Agreement.
