## COMMITTEE SUBSTITUTE FOR ORDINANCE NO. 250500

Vacating an approximately 7,500 square—foot <u>street\_section of right-of-way</u> in \_District R-1.5 generally located <u>east west</u> of the intersection of <u>NortheastN.E.</u> Barry Road and <u>NorthN.</u> Cleveland Avenue; and directing the City Clerk to record certain documents. (CD-ROW-2025-00008)

## BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the Council of Kansas City does hereby find and declare that on the 4th day of February, 2025, a petition was filed with the City Clerk of Kansas City by Patricia Jensen for the vacation of a tract of land being located in the Northeast Quarter of the Southeast Quarter of Section 7, Township 51N, Range 32W, Kansas City, Clay County, Missouri, being more particularly described as follows: Commencing at the NortheastNorthwest Corner of the Southeast West Half of the Southwest Quarter of said Section 7, thence North 89° 15' 57"88° 23' 34" West, a distance of 1343.68184.16 feet; thence North 0° 34' 10" East 37' 57" West, a distance of 7.185.56 feet to the Point of Beginning; thence North 0° 40' 28" East, a distance of 68.58 feet; thence North 88° 47' 18"57' 07" West, a distance of 374.98148.55 feet; thence South 43° 44'44' 01"" East, a distance of 188.4390.30 feet; thence South 88° 56'56' 48"" East, a distance of 86.82 feet; thence North 0° 37'37' 57"" West, a distance of 64.13 feet; thence South 88° 57' 07" East, a distance of 157.75 to the Point of Beginning, Containing 31,068.85 Square Feet More 7,543.27 square feet more or Lessless, giving the distinct description of the street to be vacated, and also the names of the persons and corporations owning or claiming to own the property fronting thereon, and that the consent of the persons and corporations owning or claiming to own threefourths of the front feet of the property immediately adjoining said street has been obtained in writing, that said consent has been acknowledged as deeds are acknowledged, and was duly filed with the petition for such vacation in the City Clerk's Office.

Section 2. That the Council finds that the City Plan Commission has duly endorsed its approval of this Ordinance hereon.

Section 3. That the Council finds that no private rights will be unreasonably injured or endangered by this vacation and that the public will suffer no unreasonable loss or inconvenience thereby.

Section 4. That all that part of the existing right of way commencing at the Northeast CornerQuarter of the Southeast Quarter of Section 7, Township 51N, Range 32W, Kansas City, Clay County, Missouri, being more particularly described as follows: Commencing at the Northwest Corner of the West Half of the Southwest Quarter of said Section 7, thence North 89° 15' 57"88° 23' 34" West, a distance of 1343.68184.16 feet; thence North 0° 34' 10" East37' 57" West, a distance of 7.185.56 feet to the Point of Beginning; thence North 0° 40' 28" East, a distance of 68.58 feet; thence North 88° 47' 18"57' 07" West, a distance of 374.98148.55 feet; thence South 43° 44'44' 01" East, a distance of 188.4390.30 feet; thence South 88° 56'56' 48" East, a distance

of 86.82 feet; thence North 0° 37'37' 57". West, a distance of 64.13 feet; thence South 88° 57' 07" East, a distance of 157.75 to the Point of Beginning, Containing 31,068.85 Square Feet More 7,543.27 square feet more or Less less, be and the same is hereby vacated, and subject to the following conditions:

- 1. That the applicant allow AT&T 30-60 days to issue the project to retire cables in the vacated right-of-way.
- 2. That the applicant shall retain all utility easements and protect facilities required by Evergy.
- 3. That the applicant shall retain all utility easements and protect facilities required by Spectrum Charter.
- 4. That the applicant shall retail all utility easements and protect facilities required by <a href="the-water-Services">the Water Services</a> <a href="Department">Department</a>.

Section 5. That the City Clerk of Kansas City, Missouri, be and she is hereby authorized and directed to acknowledge this ordinance as deeds are acknowledged, and to cause this ordinance and the consent of property owners hereinbefore referred to, to be filed for record in the Recorder's Office in <u>JacksonClay</u> County, Missouri.

Section 6. All Ordinances or parts of Ordinances in conflict with this Ordinance are, in so much as they conflict with this Ordinance, hereby repealed.
