<p><b>Discussion</b> <i>(including relationship to other Council actions)</i></p> <p>On April 10, 2019, a Parks &amp; Recreation Department employee was traveling eastbound on 17th Street when at Wyoming Street, the City driver failed to yield the right of way and struck the claimant who was traveling northbound on Wyoming Street. The City vehicle was a bus. The settlement will reimburse claimant for medical bills incurred due to the collision. The claimant was treated for a broken neck which required spinal fusion surgery.</p>
