Executive Summary

Authorizing a \$900,000.00 Design Professional Services Amendment No. 1 to Contract No. 1704 with Burns and McDonnell Engineering Company Inc. for the Regulatory Compliance and Capital Improvement Planning Optimization project for a total contract amount of \$5,500,000.00; and recognizing this ordinance as having an accelerated effective date.

Discussion

Reason for Contract

In 2010, the City of Kansas City, Missouri entered into a Consent Decree with the United States Environmental Protection Agency (EPA) to reduce the volume and frequency of overflows from the City's sewer system. The City's Smart Sewer Program is currently in year 15 of a 30-year implementation period. This project will provide consent decree modification and compliance services to assist the City with seeking its fourth consent decree modification from the US Environmental Protection Agency to address projected changes in the City's financial circumstances. Pending new regulatory compliance obligations involving changes in the City's NPDES permit will result in additional compliance costs which will adversely impact the City's current funding plan for Consent Decree projects.

<u>Design Professional Services Contract Amendment Description</u>

City Council passed Ordinance No. 230533 on July 13, 2023, which authorized a \$4,600,000.00 design professional services contract with Burns & McDonnell Engineering Company, Inc. to assist the City with seeking its fourth consent decree modification from the US Environmental Protection Agency to address projected changes in the City's financial circumstances.

The proposed \$900,000.00 Amendment No. 1 will provide for a continuation of these services including system-wide hydraulic model calibrations and assessments for the 2024 and 2030 interim Consent Decree milestone compliance requirements; and up to 80 diversion structure surveys. Design Professional will perform hydraulic model calibrations using flow meter data from completed projects and diversion structure

surveys and then perform a system-wide model update in support of Consent Decree Compliance.

Design Professional Services Contract Cost Summary

• Original Contract: \$4,600,000.00

Term

The term of the design professional services project will be 365 calendar days for proposed Amendment No. 1. The overall term for this project will be 1,095 calendar days.

MBE/WBE Goals

CREO KC established goals of 15% MBE and 10% WBE on the design professional services project on June 22, 2023.

Solicitation

The design professional services project was originally advertised in accordance with the City's requirements. One proposal was received on December 29, 2016.

<u>Awardee/Subcontracting Participation</u>

Burns & McDonnell Engineering Company, Inc. was selected for this project in accordance with Code of Ordinance Section 3-31(b)(1) Citywide selection with subcontracting participation of 15% MBE and 10% WBE.

Service Level Impacts

In 2010, the City of Kansas City, Missouri entered into a Consent Decree with the United States Environmental Protection Agency (EPA) to reduce the volume and frequency of overflows from the City's sewer system over a 25-year period. In March 2021, the Consent Decree was modified to include additional interim and revised final performance criteria and to extend its duration to 30 years. This project will provide consent decree modification and compliance services to assist the City with seeking its fourth consent decree modification from the US Environmental Protection Agency to address projected changes in the City's financial circumstances.

Other Impacts

 The project will protect public health and the environment by restoring sewer conveyance capacity, increasing the service life of the existing sewer system, and improving the water quality of the City's waterways.

 - The 2020 2024 Adopted Citywide Business Plan includes the development of environmentally sound and sustainable infrastructure strategies and a tactic to reduce financial impacts of the City's Smart Sewer Program by proactively working with the EPA to adjust the timeline for project completion. Obtaining input from City leadership will be essential prior to submitting the City's proposed consent decree modification to EPA for approval.
