**Discussion**  
**Project Justification**  
 The Water Services Department is undertaking this project to improve distribution system reliability, increase hydraulic conveyance capacity, and support fire protection in the area on or near Main Street in advance of the KC Streetcar Extension construction project.

**Construction Project Description**  
 The scope of work for the construction project includes replacement of approximately 21,492 LF of 6-inch, 8-inch, 12-inch, 16-inch, 24-inch, 36-inch, and 42-inch water mains in the area of Main Street from Pershing Avenue to E. 51st Street, in Kansas City, Jackson County, Missouri.

The specific areas with mains to be replaced and other distribution system improvements within the project limits consist of the following:

- Line A – Along Main Street from W. Pershing Road to Emanuel Cleaver II Boulevard (KC Streetcar Main Street Extension Area).
- Line B – Along Brookside Boulevard from Emanuel Cleaver II Boulevard to E. 51st Street (KC Streetcar Main Street Extension Area).

This project also includes sewer rehabilitation within the Streetcar corridor, which includes rehabilitation of existing manholes and service laterals, approximately 24,000 LF of combines sewer and relocation of approximately 4,200 LF of new sewer pipe.

The amount of this construction contract is \$22,209,451.00.

**Design Professional Services Contract Summary**  
 City Council approved Ordinance No. 180670 on September 13, 2018, which authorized \$813,772.00 for a Design Professional Services contract for the Water Main Replacement in the Area of Main Street from Pershing Avenue to E. 51st Street project. This project entailed relocation of existing water mains located on or near Main Street in advance of the KC Streetcar Extensions (Main Street and Riverfront) construction activities to limit future interference between water main maintenance and KC Streetcar operation. This project also replaced certain break-prone or obsolete water mains and appurtenances and providing other distribution system improvements within the project limits.
