**Reason for Contract**  
 Reducing an appropriation in the amount of \$1,620,000.00 in the Water Fund; appropriating that amount to the 63rd Street Roadway Improvements account; authorizing the Director of Public Works to enter into a \$7,520,000.00 Design-Build services agreement with Radmacher Brothers Excavating, Inc. for Project No. 89008711, 63rd Street Section 1 Reconstruction, Woodland Avenue to Prospect Avenue Project; and recognizing this ordinance as having an accelerated effective date.

**Project Justification**  
 Sixty-third (63rd) Street is an established route in the major street plan and is an important corridor in this area of KCMO. The roadway is in need of complete reconstruction due to pavement failure and deterioration of subgrade. Existing sidewalks are in disrepair and there are no bicycle facilities.

**Project Description**  
 The project will reconstruct 63rd Street, from Woodland Avenue to Prospect Avenue, including revisions to vertical and horizontal roadway alignment, improved intersection design, improved subgrade, new pavement, curb & gutter with underground stormwater system, new sidewalk and multi-use trail, new waterlines, and energy efficient LED streetlighting.
