The resolution further instructs the City Manager to engage with relevant stakeholders and identify potential funding streams to support the program. A report detailing the proposed plan and funding sources is to be presented within 180 days, ensuring progress and accountability in advancing economic mobility initiatives.

Councilmember Melissa Patterson-Hazley, presented. It also estimates revenue in the 2025A Taxable Special Obligation Bond Fund, appropriates \$20,000,000 from the fund's Unappropriated Fund Balance, and designates requisitioning authority. Additionally, it authorizes the Director of Finance to close project accounts upon completion and establishes effective dates to ensure timely execution of the project.

Recommendations were provided to streamline hiring timelines and improve accountability, supporting more effective workforce management.
