

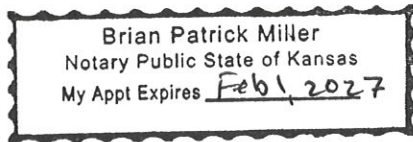

The watermain must be installed and transition from restrained to unrestrained where the plans call it out. All fittings and valves shall be restrained using backing blocks or mega lugs. The existing services must be located and reconnected to the new main once it has been tested and approved. All residents will have to be notified and kept informed as to the schedule. All areas will need to be restored per KCMO street patch and restoration details.
- H. While there are always unforeseen issues on construction projects, we will be vigilant in our efforts to see them and deal with them before they arise.



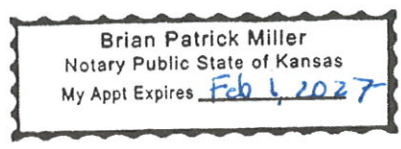
