Procurement Background

It is in the City's best interest to have a competitive bidding environment to reduce project costs. For Water Service's last progressive design-build procurement, the Department received only two bids from Goodwin Brother's and Burns and McDonnell. Three bidders are significantly preferred and may reduce project costs by up to 10% versus one or two bidders. Burns and McDonnell has elected to pursue the SB2 project as a design-builder, which will increase the bidding pool and potentially decrease our project costs. Black & Veatch Engineering (B&V) has been a core subcontractor to Burns and McDonnell to complete the Water Masterplan, starting from the team's proposal and selection. B&V desires to be the Designer and Owner's Advisor on the SB2 Upgrades. They are a large capable firm which has the staff and abilities to function as our Owner's Advisor.

Water Services has the ability to utilize a specialized waiver for follow-on phase work via Section 3-7(a)(3) of the Code of Ordinances:

"Specialized waivers - design professional contract. Regardless of the initial dollar amount of any design professional contract, the city may elect to utilize the same design professional or a subcontractor thereto on a subsequent design phase or for additional design work without a new qualification based selection process provided that the subsequent phase or additional work is to be performed on the same project for which the design professional was originally selected. If the city and the design professional or subcontractor thereto cannot agree on reasonable compensation for the subsequent design phase or additional design work, the city shall solicit and award a design professional contract in the manner otherwise prescribed in this article."

The project fee is above the \$400,000 threshold; and therefore, this contract will need Council approval.

Project Background

The City would be approximately 1 million gallons per day short water capacity if all our wholesale customers in the SB2 pressure zone exercised their options in existing agreements. Therefore, it is in the City's interest to pursue the SB2 project quickly by utilizing B&V to provide Design and Owner's Advisor Services. Furthermore, B&V understands the current capabilities and equipment in use for the proposed SB2 project. B&V's work on the masterplan project has been timely, cost effective, and of good quality.

Project Details

The project would consist of providing a conceptual (10%) design of a new High Grove pump station, improvements at the Prospect pump station, and installation of transmission lines to and from the pump stations to support development and wholesale customers in the SB2 pressure zone. B&V would also assist the Department in discussion with our major wholesale customer, Lee's Summit about upgrades and coordinating projects at our 150 HWY connection. Our Owner's Advisor will also assist us in developing procurement documents, bidding assistance, and Contractor outreach to help create a competitive bidding environment. The project will ensure redundancy during the non-peak demand days, via the increased pumping capacities of the high grove and prospect road pump stations.


