#### ORDINANCE NO. 250911

Sponsor: Councilmember Kevin O'Neill

Directing the City Manager to issue a traffic control permit for St. Paul's Episcopal Day School for the closure of Walnut Street between East 40th Street and East 41st Street during school hours; and directing the City Manager to approve any permits related to traffic calming projects by St. Paul's along the same road.

WHEREAS, traffic calming is a combination of measures that aim to balance traffic on streets by altering behavior of motor vehicle drivers and improving conditions for pedestrians and bicyclists by utilizing techniques to lessen the impact of motor vehicle traffic by slowing it down or "calming" it; and

WHEREAS, traffic calming strategies often include changes to the streets including speed bumps and lane narrowing; using planters, bollards and other removable barriers; eliminating or adding parking or installing sidewalk extensions or similar structures with temporary materials; and including visual enhancements like painting lines, colors and patterns as well as adding trees, flowers and other amenities; and

WHEREAS, the City supports these traffic calming projects as they can improve safety for pedestrians, cyclists and motorists at intersections; can aid in reducing traffic speed and motor-vehicle collisions; can increase pedestrian and bicycling activity; and adds aesthetic enhancements and improves visibility;

WHEREAS, the subject section of Walnut Street between East 40th Street and East 41st Street currently only allows one-way traffic north to south; and

WHEREAS, St. Paul's Episcopal Day School maintains educational facilities on both sides of Walnut Street in the subject section; and

WHEREAS, allowing closure of Walnut Street between East 40th Street and East 41st Street during school hours will improve safety for the students, faculty, staff and community of St. Paul's Episcopal Day School and additional traffic calming measures will improve safety for the all residents during afterhours and the weekends; and

WHEREAS, the project will be fully funded and maintained by St. Paul's Episcopal Day School; and

WHEREAS, the City will further support the projects and maintain public safety through ensuring the locations and paint colors selected do not impede with other street markings intended for traffic control and that the additions of planters and other installations are in conformance with City regulations; NOW, THEREFORE,

#### BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the City Manager is directed to issue a traffic control permit for St. Paul's Episcopal Day School for the temporary closure of Walnut Street between 40th Street and 41st Street during school hours for the 2025-2026 school year.

Section 2. That the City Manager is directed to approve any needed permits related to the design and locations of traffic calming projects along the road so long as they do not impede with other street markings, traffic controls or public safety.

Traffic calming strategies often include changes to the streets including speed bumps and lane narrowing; using planters, bollards and other removable barriers; eliminating or adding parking or installing sidewalk extensions or similar structures with temporary materials; and including visual enhancements like painting lines, colors and patterns as well as adding trees, flowers and other amenities; and

The City supports these traffic calming projects as they can improve safety for pedestrians, cyclists and motorists at intersections; can aid in reducing traffic speed and motor-vehicle collisions; can increase pedestrian and bicycling activity; and adds aesthetic enhancements and improves visibility;

The subject section of Walnut Street between East 40th Street and East 41st Street currently only allows one-way traffic north to south; and

St. Paul's Episcopal Day School maintains educational facilities on both sides of Walnut Street in the subject section; and

Allowing closure of Walnut Street between East 40th Street and East 41st Street during school hours will improve safety for the students, faculty, staff and community

of St. Paul's Episcopal Day School and additional traffic calming measures will improve safety for the all residents during afterhours and the weekends; and

The project will be fully funded and maintained by St. Paul's Episcopal Day School; and

The City will further support the projects and maintain public safety through ensuring the locations and paint colors selected do not impede with other street markings intended for traffic control and that the additions of planters and other installations are in conformance with City regulations.

## **Executive Summary**

Authorizing a Water Transmission Main Cooperative Agreement for the Mandacina First Plat, located at 9550 and 9600 N. Brooklyn Avenue, in Kansas City, Clay County, Missouri.

### **Discussion**

#### **Project Justification**

John C. Pisciotta and Joseph C. Mandacina (Owner), owners of the development of land generally located at 9550 and 9600 N Brooklyn Avenue, Kansas City, Clay County, Missouri 64155 are pursuing approval of a Preliminary Plat (Case CD-CPC-2024-00056) for the property.

The project has a future 30" water transmission main and a future arterial street (96th Street) running through very challenging terrain near the center of the property.

The City Plan Commission ("CPC") dismissed the case while the Owner worked through infrastructure requirements with the City.

The City has determined that a portion of the Owner's required water main improvement obligations may be satisfied by entering into and fulling this Cooperative Agreement.

#### **Project Description**

The City and Owner enter into this Cooperative Agreement pursuant to Section 70.210 et seq., Revised Statutes of Missouri, 2018, (RSMo.), to provide for a portion of the installation of a 30" water transmission main (the "Improvements"). The purpose of this Agreement is to clarify the party's obligations for the Improvements and to fulfill a condition of platting.

The City is subject to appropriation and, if necessary, Council approval, when said funding is made available to the City through GO Bonds, PIAC funds, grants, or other

funding sources outside of KC Water funds, and 96th St is approved and funded for construction between Maplewoods Pkwy and Brooklyn Ave, the City agrees to:

- Prepare, or have prepared, construction plans and specifications, for the City's portion of the Improvements.
- Construct, or cause to be constructed, approximately 1200' of the 30" water transmission main as part of the construction of 96th Street. This segment of 96th Street would extend from Brooklyn Avenue westward to Maplewoods Parkway.

#### The Owner agrees to

- Prepare, or have prepared, construction plans and specifications, for the Owner's portion of the Improvements prior to approval of the final plat.
- Enter into a construction agreement with KC Water for approximately 250' of 12" water distribution main as part of their construction of 96th Street prior to the release of the final plat for recording. This segment of 96th Street would extend from Maplewoods Parkway eastward toward Brooklyn Avenue.
- Secure all required permits from the City prior to the release of the final plat for recording.
- Dedicate the full width of right-of-way needed for 96th St between Maplewoods Pkwy and Brooklyn Ave. and any necessary slope easements, along with a 30' wide exclusive water easement adjacent to the right-of-way on the final plat.

#### **Property Description**

Amending Chapter 70, Article XII of the Code of Ordinances, entitled "Traffic Control Signs, Signals, and Devices," by amending Sections 70-954 of the Code of Ordinances to prohibit right turns in school zones when school zone speed limits are in effect.

WHEREAS, the City has a fundamental responsibility to protect the health, safety, and welfare of all residents, particularly the children of Kansas City; and

WHEREAS, the tragic death of an elementary student at an intersection near a school has highlighted the urgent need for enhanced traffic safety measures in school zones; and

WHEREAS, students walking, biking, and traveling to and from school are among our most vulnerable road users and deserve the highest level of protection; and

WHEREAS, school zones experience concentrated periods of pedestrian activity during arrival and dismissal times, creating heightened risk for vehicle-pedestrian conflicts; and

WHEREAS, eliminating right turns on red during school zone hours will reduce potential conflict points between vehicles and student pedestrians, particularly in intersections adjacent to schools; and

WHEREAS, this ordinance is consistent with the City's commitment to Vision Zero principles and the goal of eliminating traffic-related deaths and serious injuries on Kansas City streets; NOW, THEREFORE,

#### BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That Chapter 70, Code of Ordinances of Kansas City, Section 70-954(a)(3)c is hereby amended to read as follows:

#### Sec. 70-954. Traffic control signal legend.

(a) Whenever traffic is controlled by traffic control signals exhibiting different colored lights, or colored lighted arrows, successively one at a time or in combination, only the colors green, red and yellow shall be used, except for special pedestrian signals carrying a word legend, and the lights shall indicate and apply to drivers of vehicles and pedestrians as follows:

#### (1) *Green indication.*

- a. Vehicular traffic facing a circular green signal may proceed straight through or turn right or left unless a sign at such place prohibits either such turn. But vehicular traffic, including vehicles turning right or left, shall yield the right-of-way to other vehicles and to pedestrians lawfully within the intersection or an adjacent crosswalk at the time such signal is exhibited.
- b. Vehicular traffic facing a green arrow signal, shown alone or in combination with another indication, may cautiously enter the intersection only to make the movement indicated by such arrow, or such other movement as is permitted by other indications shown at the same time. Such vehicular traffic shall yield the right-of-way to pedestrians lawfully within an adjacent crosswalk and to other traffic lawfully using the intersection.
- c. Unless otherwise directed by a pedestrian control signal as provided in <u>section 70-956</u>, pedestrians facing any green signal, except when the sole green signal is a turn arrow, may proceed across the roadway within any marked or unmarked crosswalk.
- (2) Steady yellow or yellow arrow indications.
  - a. Vehicular traffic facing a steady circular yellow or yellow arrow signal is thereby warned that the related green movement is being terminated or that a red indication will be exhibited immediately thereafter.
  - b. Pedestrians facing a steady circular yellow or yellow arrow signal, unless otherwise directed by a pedestrian control signal as provided in <u>section 70-956</u>, are thereby advised that there is insufficient time to cross the roadway before a red indication is shown, and no pedestrian shall then start to cross the roadway.

#### (3) Steady red indication.

- a. Vehicular traffic facing a steady circular red signal alone shall stop at a clearly marked stop line, but, if none, before entering the crosswalk on the near side of the intersection, or, if none, then before entering the intersection, and shall remain standing until an indication to proceed is shown, except as provided in subsection (a)(3)c of this section.
- b. Vehicular traffic facing a steady red arrow signal shall not enter the intersection to make the movement indicated by the arrow, and, unless entering the intersection to make a movement permitted by another signal,

shall stop at a clearly marked stop line, but, if none, before entering the crosswalk on the near side of the intersection, or, if none, then before entering the intersection, and shall remain standing until an indication permitting the movement indicated by such red arrow is shown, except as provided in subsection (a)(3)c of this section.

- c. Except when a sign is in place prohibiting a turn, vehicular traffic facing any steady red signal may cautiously enter the intersection to turn right, or to turn left from a one-way street into a one-way street, after stopping as required by subsection (a)(3)a or subsection (a)(3)b of this section. After stopping, the driver shall yield the right-of-way to any vehicle in the intersection or approaching on another roadway so closely as to constitute an immediate hazard during the time such driver is moving across or within the intersection or junction of roadways. Such driver shall yield the right-of-way to pedestrians within the intersection or an adjacent crosswalk.
  - 1. *School zones*. No vehicular traffic shall make a right turn on a steady red signal within a designated school zone during the hours when the school zone speed limit is in effect, regardless of whether a sign is present prohibiting such turn.
- d. Unless otherwise directed by a pedestrian control signal as provided in <u>section 70-956</u>, pedestrians facing a steady circular red signal or red arrow signal alone shall not enter the roadway.
- (b) If an official traffic control signal is erected and maintained at a place other than an intersection, the provisions of this section shall be applicable, except as to those provisions which by their nature can have no application. Any stop required shall be made at a sign or marking on the pavement indicating where the stop shall be made, but in the absence of any such sign or marking the stop shall be made at the signal.

Section 2. That the Director of Public Works is hereby authorized and directed to place and maintain appropriate signage at all affected intersections within school zones to provide notice of the prohibition on right turns on red signals during school zone hours, in accordance with Section 70-951 and in conformance with the Manual on Uniform Traffic Control Devices and design standards of the city department of public works as required by Section 70-952, within 180 days after passage of this ordinance.

Section 3. That for purposes of this ordinance, "school zone" shall mean those areas designated by the Director of Public Works pursuant to applicable traffic control ordinances and identified by appropriate traffic control devices, and "school zone hours" shall mean those times during which reduced school zone speed limits are in effect as posted.

Section 4. The Director of Public Works may grant a waiver from the prohibition on right turns on red signals established in Section 70-954(a)(3)c.1 for specific intersections within

### **Discussion**

The 60% plans were originally developed by Olsson under a contract with Hunt Midwest. Direction of the project was transferred to the City after it was on hold for a while and City staff identified additional work that would be necessary to update the plans. The Shoal Creek Trail project will cross the N Brighton project and additional information and survey data is necessary to ensure the projects would meet seamlessly. ### **Discussion**

### Construction Project Justification

### **Discussion**

### Project Justification/Project Description

The City Council established the Water Services Utility Funding Task Force in 2016 to integrate community values into a funding strategy for its water, wastewater, and stormwater utilities.

The Water Services Utility Funding Task Force recommended increasing the amount of customer assistance to benefit eligible low-income households to help pay for their water, wastewater, and stormwater utility bills.

The Water Services Department (WSD) desires to continue a public assistance program to aid low-income residents in payment of their water bills. WSD wants to contract with one umbrella social service agency, which then coordinates assistance with the other local social services agencies.

The Mid America Assistance Coalition (MAAC), a not-for-profit corporation, is a coordinating agency for emergency assistance organizations and homeless services providers in the Kansas City area. WSD sets the eligibility criteria and then sends payments to MAAC. Through MAAC, local social service agencies will be able to access a database and tap into the funds when a client meets the eligibility criteria. The social service agency will then write the check to WSD on behalf of the client.

MAAC has distributed utility funds to Kansas City area agencies since 1982, and currently provides this assistance service for Evergy (formerly known as Kansas City Power & Light) and others. MAAC uses MAACLink, a centralized computer database

system to fund and track performance of area agencies and the distribution of financial resources. Currently, their system links funding sources through more than fifty (50) agencies in the local service area. Through this program, they are able to meet our reporting requirements for all monies provided.

#### Term

The term of this project will be 365 days for Renewal No. 1. There will also be two successive one-year renewal options with further City Council approval. #### Sec. 70-962. Pedestrian signal programming policies and standards.

- (a) General principles. For all signalized intersections:
  - 1. Pedestrian Demand shall be used to determine locations where pedestrian signals are to be automated.
  - 2. Exceptions to the automated pedestrian signals shall have a clearly explained rationale.
- (b) Lower demand intersections and exceptions.
  - 1. Pedestrian signals shall always activate on both sides of the street when the signal is pressed.
  - 2. When the length of the green light phase is equal to or greater than the length of the pedestrian crossing time, the pedestrian signal shall be active when the green light is activated.
  - 3. When the length of the green light phase is long enough, the pedestrian signal shall still activated after green light begins.
  - 4. The pedestrian signal change interval shall last until the vehicular yellow signal begins.
- (c) Principles based on demand.

- 1. Tier One: Specific intersections and corridors where walking is in high demand, such as intersections within the Country Club Plaza, the Downtown Loop, the Crossroads, and the River Market, shall have pedestrian signals programmed according to the following guidelines:
  - i. Leading Pedestrian Intervals shall be the default setting.
  - ii. Pedestrian signals shall be initiated by automation to provide an adequate pedestrian interval.
  - iii. Push button initiation shall be used to prompt the walk signal at locations where the technology allows.
  - iv. Push button initiation shall be used to request longer pedestrian intervals where the technology allows.
  - v. Road diet studies may be conducted to explore potential reduction of dependency on traffic signals.
- 2. Tier Two: Areas around educational institutions, high frequency corridors, or within three blocks of a major transit stop, shall have pedestrian signals programmed according to the following guidelines:
  - i. Pedestrian signals shall be initiated by automation to provide an adequate pedestrian interval.
  - ii. Push button initiation shall be used to prompt the walk signal at locations where the technology allows.
  - iii. Push button initiation shall be used to request longer pedestrian intervals where the technology allows.
  - iv. Road diet studies may be conducted to explore potential reduction of dependency on traffic signals.
  - v. Leading Pedestrian Intervals are encouraged.
- 3. Tier Three: Moderate Pedestrian Demand.
  - Push button activation highly discouraged and shall only be used in locations where automation would cause major disruptions in traffic or transit operations.
  - ii. All pedestrian signals shall be automated for trail crossings.
  - iii. Push button activation prohibited on at-grade trail crossings or designated bike routes.
- 4. Tier Four: Low Pedestrian Demand.
  - i. Push button activation acceptable but highly discouraged.
  - ii. Walk signal will illuminate with the adjacent green light phase as long as it doesn't affect existing timing.
  - iii. Push button activation may lengthen the walk signal or activate it sooner.
  - iv. Push button activation highly discouraged on at-grade trail crossings or designated bike routes.

# **Executive Summary**

Amending Chapter 70, Code of Ordinances, entitled "Traffic and Vehicles" by enacting a new section 70-962 entitled "Pedestrian signal programming policies and standards" for the purpose of instituting policies and standards related to pedestrian crossing signals; establishing an effective date; and directing the City Manager to provide periodic updates regarding implementation progress every 45 days to the Transportation, Infrastructure, and Operations Committee.

### **Discussion**

This ordinance amends Chapter 70, Code of Ordinances, Traffic Control Signs, Signals, and Devices, for the purpose of creating a standard for pedestrian crossing signals. The amendment categorizes traffic intersections into four tiers, based on pedestrian demand, with different guidelines for each tier.
