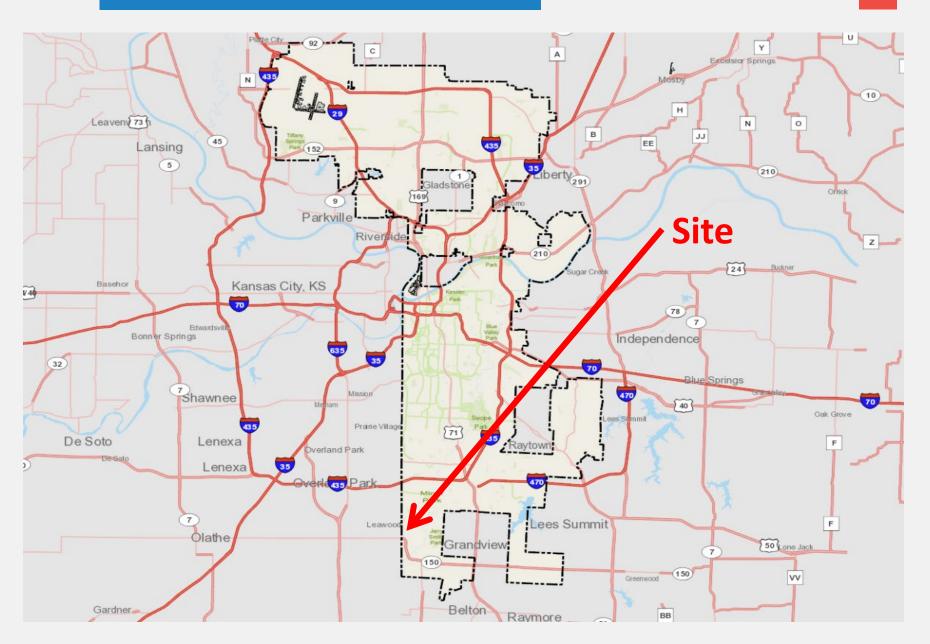

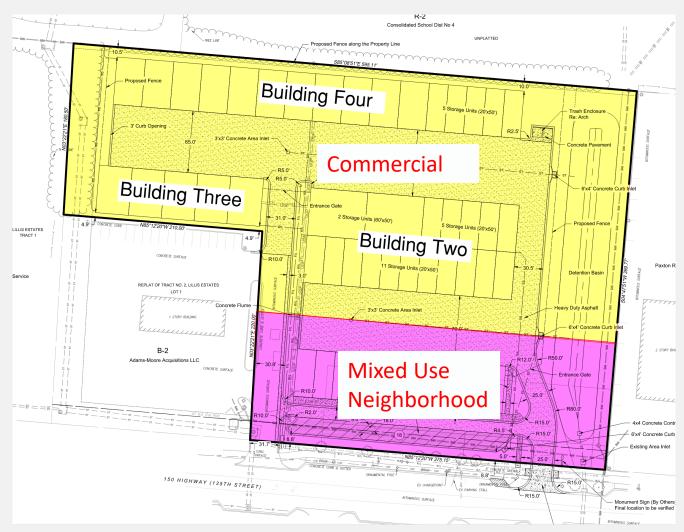
# **Existing Zoning and Future Land Use**





# Rezoning and Area Plan Amendment

- Parcels are currently zoned B2-2
- Applicant is requesting a rezoning to MPD (Master Planned Development).
- Community Planning
  Division Requested a split
  Area Plan Amendment of
  the north side of lot from
  Mixed Use Neighborhood
  to Commercial





### Site Plan

- Applicant is proposing 4 buildings
- Three buildings on the north side of lot are "FlexCaves". For storage- marketed toward higher end collectors and allows for flexibility in uses in buildings
- Building along East 135<sup>th</sup> Street will have 11 "ShopCaves" where businesses can have logistics/storage and have a store front.
- Staff requested that parking along 135<sup>th</sup> be moved to the side of the building to fix contextually with historic buildings to the east, applicant added additional landscaping but did not move parking.

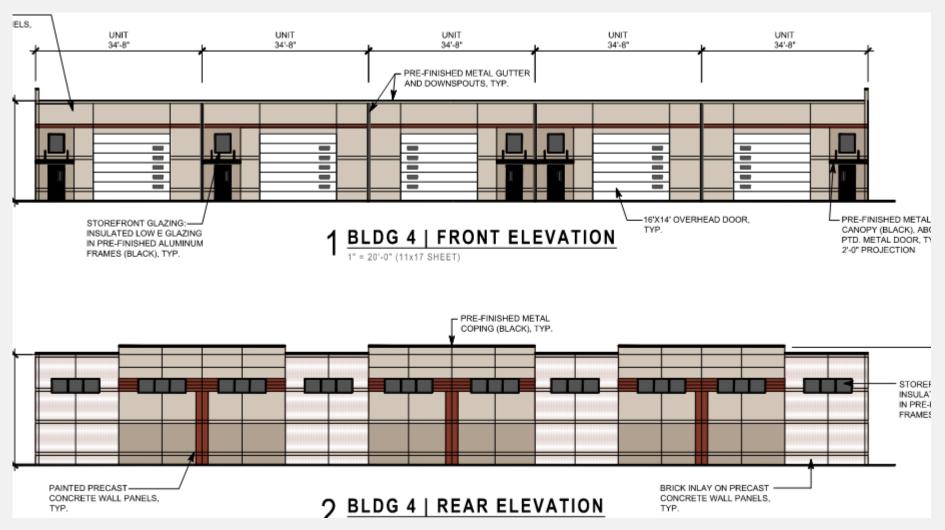

### **Allowed Uses**

Allowed uses within the storefront units in Building 1 shall be limited to uses allowed within the B2 Zoning District.

Allowed uses within Buildings 2, 3, and 4 are limited to Self Storage Warehouse, Manufacturing, Production (Artisanal), Warehousing, Wholesaling, Storage, and Freight Movement (Indoor), Sports and Recreation, Participant (Indoor), Personal Improvement Services, Business Equipment Sales and Services, Building Maintenance Services, Artist Work or Sales Space, Food and Food Storage, and Office, Administrative, Professional or General. No outdoor storage is permitted.
