RE: Petition for the Establishment of the Crossroads Community Improvement

District

Per Section 74-303 of Chapter 74 of the Kansas City Code of Ordinances, this memorandum is provided for the purpose of addressing the criteria that the City Council is obligated to consider prior to approving a petition to establish a Community Improvement District (a "CID") as authorized by the Missouri Community Improvement Act, §67.1401, *et seq.*, RSMo, as amended (the "CID Act").

I. 74-303(a) Considerations

(1) Alignment with city goals expressed in the city's comprehensive plan, area plans, and economic development policies.

The Crossroads Arts District has emerged as one of Kansas City's most vibrant economic centers, home to thousands of residents, hundreds of local businesses and many outdoor community events and street performances including First Fridays. In recognition of its growing prominence, the area's own residents and businesses have proposed formation of the Crossroads Community Improvement District (the "District").

The District is within the area of the Greater Downtown Area Plan (the "GDAP"), the adopted Comprehensive Plan for this portion of the City. The GDAP's overarching Vision Statement is

We must focus on connecting our neighborhoods to create a strong urban community, flourishing with diversity, fostering business, maintaining historic neighborhood identities, and sustaining a safe, vibrant, and healthy Greater Downtown Area for current and future generations.

In furtherance of the GDAP's Vision Statement, there are five Primary Goals. The proposed District's focus on streetscape improvements, security, waste management and graffiti removal in the neighborhood, and supporting First Fridays, directly promote the four of such Primary Goals, specifically (1) Creating a Walkable Downtown (among other

things, the proposed District would as part of its services enhance and protect streetscape landscaping, and manage graffiti, and increase pedestrian traffic), (2) Doubling the Population Downtown (among other things, the proposed District would attract and retain residents by providing and enhancing a dynamic urban experience), (3) Increasing Employment Downtown (among other things, the proposed District would provide stability and support to small businesses and increase the employee pool living downtown), and (4) Retain and Promote Safe, Authentic Neighborhoods (among other things, the community-oriented services to be provided by the proposed District align fully with City's goals of creating safe, beautiful, and exciting neighborhoods with improved public spaces. Indeed, the goals of the proposed District are wholly consistent with the City's goals for the greater Downtown area in general as expressed in the GDAP.

(2) Benefits to the community with preference for petitions that allocate at least ten percent of the CID's total projected sales tax revenues toward community benefits and services, including blight remediation.

As set out in the District's proposed Five-Year Plan, \$9.6 million (representing approximately 100% of the District Revenue after administrative costs) will be dedicated to generalized public benefits over the proposed ten-year term of the District. These benefits include management of First Friday events (significant cultural and economic drivers for the City); streetscape and landscape improvements within the District; expanded security services; waste management services; graffiti removal services; and the creation of additional greenspace within the District. All of these services will directly benefit both the property owners within the District, the broader community, and nonresident tourism by enhancing the safety, cleanliness, and appeal of the Crossroads Art District.

(3) Whether there are any existing CIDs within the boundaries of the proposed District and if such existing CIDs support the establishment of the proposed CID as evidenced by a letter or similar evidence of support.

There are two small undeveloped parcels within the proposed District that are also within the Performing Arts Center CID. One parcel (City Pin 249053, owned by Mozart Properties, LLC) is 0.089 acres and sits west of Webster House. The other parcel (City Pin 245738, owned by PAC Holding Inc.) is 1.426 acres and sits across Wyandotte Street from the Performing Arts Center. These parcels represent an extremely minimal overlap to the District overall, and such small parcels may or may not ever develop. The proponents of the District are in discussions with representatives of the owners of such parcels and the Performing Arts Center CID and will provide a report to Council with respect to those discussions at the hearing on this Petition.

(4) The current tax rate and a breakdown of taxes being imposed within the proposed CID boundaries, how the proposed overall tax rate compares to neighboring cities in Missouri, and any impact on the City's ability to impose additional taxes. Such information shall be provided by the finance department.

The CID proposes to impose a .5% sales tax within its boundaries in addition to a special assessment under a formula set out in the proposed District's Petition.

The following was provided by the City's Finance Department:

- There are multiple sales tax rates charged within the proposed CID boundaries:
 - Parcels east of Campbell have a rate of 8.975%
 - Most of the parcels are within the Main Street Rail TDD which have a rate of 9.975%
 - Parcels near 19th & Walnut are within the PID 4 Corrigan Station and have a rate of 10.975%
 - Two proposed parcels are within the Performing Arts CID which have a rate of 10.975%
- The tax rates in neighboring cities in Missouri
 - Neighboring cities in Missouri have sales taxes ranging from 5.475% to 10.850%. There are currently other areas within the City of Kansas City with existing tax rates of 11.975%.
 - See information here: https://missouri.ttr.services/ and on the attached spreadsheet from the Missouri Department of Revenue
- Any impacts the City's ability to levy additional sales taxes
 - The proposed CID would not impact the ability of the City's to levy additional sales taxes.
- (5) Whether a shorter term is desirable based upon the nature of improvements and services and the projected budget.

The proposed term for the District is ten (10) years, which is substantially shorter than the maximum permitted term of a Community Improvement District under the Missouri CID Act and City Code. This duration is considered to be sufficient as an initial term to afford enough time to get the District up and running and confirm the usefulness and desirability of the District for future terms, if any.
