CDBG and ESG Programs

Community Development Block Grant (CDBG)

All program activities must meet at least one of these national objectivities

- Principally benefit low- and moderate-income persons who earn at or below 80% of the area median income
- Aid in the prevention of elimination of slums or blight
- Activities that meet needs having a particular urgency

Emergency Solutions Grant (ESG)

- Emergency Shelter renovation, major rehab or conversion; essential services; shelter operations
- Prevention Services housing relocation and stabilization services and short-and/or mediumterm rental assistance;
- Rapid Re-Housing permanent housing relocation stabilization services and short-and/or medium-term rental assistance;
- Essential Services-case management, engagement, transportation
- Data Collection- Homeless Management Information System (HMIS)
- Administration in accordance with 24 CFR Part 576.



One-Year Action Plan: HOME and HOPWA

Housing and Community Services Department

HOME Investment Partnership Grant (HOME)

Funds may be used to assist low-and moderate-income homebuyers and homeowners and for development of rental housing and homeownership opportunities which is affordable to low- and moderate-income persons

Housing Opportunities for Persons with AIDS Grant (HOPWA)

Funds are used to provide housing assistance and supportive services to low-income persons with HIV/AIDS and their families.



2024 Program Category Highlights

CDBG

New Fund Participation from the following Public Services:

- Boys & Girls Club of Greater KC (Youth)
- KC Shepard's Center (Senior Population)

Allocated additional dollars to Minor Home Repair to support qualifying applicant needs for services

HOME

All HOME recommended projects fully supported through "funding ask"

ESG

Sustained ESG applicant participation from 8 recommended projects as shelter operations

HOPWA

Received an additional \$20K this fund year to support HOPWA



Contract Overview

Per Housing and Community Development Department's policy, projects will have up to 12 months after the approved ordinance to contract with the city, and up to 5 years to complete a project, per ordinance Section 74-12.

- Initial 2 year contract
- Renewals approved for 1 year up to 5 years total on a case-bycase approval
- Project Encumbrance is based on an actual executed contract, not the date of HCDD grant period
- Funds may not be used for anything prior to the date of the executed contract
