Executive Summary

Authorizing a \$2,883,748.63 construction contract with Leath & Sons, Inc., for the Water Main Replacement in the Area of Askew Avenue to Oakley Avenue, E. 14th Terrace to E. 29th Street project; authorizing a maximum expenditure of \$3,172,123.49; and recognizing this ordinance as having an accelerated effective date.

Discussion

Project Justification

The Water Services Department is undertaking this construction project to improve distribution system reliability, increase hydraulic conveyance capacity, and support fire protection to replace aging, break-prone cast iron pipe (CIP) water mains with ductile iron pipe (DIP).

Project Description

This project includes the replacement of approximately 7,646 linear feet (consisting of 1,062 LF of 16-inch, 1,045 LF of 12-inch, 319 LF of 8-inch, and 5,220 LF of 6-inch) break-prone or obsolete water mains and appurtenances and providing other distribution system improvements within the within the area of Askew Avenue to Oakley Avenue and E. 14th Terrace to E. 29th Street, in Kansas City, Jackson County, Missouri.

The specific mains to be replaced and other distribution system improvements within the project limits consist of the following:

- E. 14th Terrace from Cleveland Avenue, E. 14th Terrace to Jackson Avenue;
- E. 14th Terrace from Norton Avenue to Jackson Avenue;
- E. Truman Road from Myrtle Avenue to Norton Avenue;
- E. Truman Road from Norton Avenue to Jackson Avenue;
- Lawn Avenue from E. Truman Road to E. 16th Street;
- Cleveland Avenue from E. 17th Street to Bernard Powell Drive/E. 18th Street;
- E. 17th Street from Cleveland Avenue to the E. 17th Street intersection;
- E. 19th Street from Askew Avenue to Monroe Avenue;
- E. 20th Street from Askew Avenue to Monroe Avenue;

- E. 21st Street from Askew Avenue to Monroe Avenue;
- Askew Avenue from E. 19th Street to E. 20th Street;
- Askew Avenue from E. 20th Street to E. 21st Street;
- Askew Avenue from E. 21st Street to E. 23rd Street;
- Askew Avenue from E. 21st Street to E. 23rd Street;
- Quincy Avenue from E. 28th Street to Raytown Road;
- Raytown Road from 2825 Raytown Road to Denver Avenue;
- Denver Avenue from E. 28th Terrace to E. 29th Street,
- E. 27th Terrace from Van Brunt Boulevard to Oakley Avenue;
- Bonita Avenue from Van Brunt Boulevard to Oakley Avenue; and
- Norton Avenue from E. 14th Terrace to Mill Lumber.

The work will include the transfer of customers' water service connections from existing water mains to new water mains. The amount of this contract is \$2,883,748.63.

Term

The term of this contract is 420 calendar days.

Solicitation

This project was advertised in accordance with the City's requirements. Public bids were opened on June 3, 2025 with 6 bidders responding.

MBE/WBE Goals

CREO KC established goals of 11% MBE and 11% WBE on this project on April 17, 2025 as part of the Annual Goal Program.

Awardee/Subcontracting Participation

Leath & Sons, Inc. was selected for this project as the lowest, most responsive, and most responsible bidder with a contract amount of \$2,883,748.63, with subcontracting participation of 11% MBE and 11% WBE.
