# **Executive Summary**

Providing additional funding for the Extreme Weather Program in an amount up to \$1,300,000.00 for total funding not to exceed \$1,724,617.00; estimating and appropriating \$500,000.00 from the Marijuana Sales Tax Fund for the Extreme Weather Program; reducing appropriations in the Contingent Appropriation of the General Fund by \$800,000.00; appropriating that amount in the General Fund for the purpose of the Extreme Weather Program; designating requisitioning authority; directing the City Manager to enter into contracts consistent with this ordinance; and directing the City Manager to report back to City Council within 30 days with a report on the implementation plan for the Kansas City Extreme Weather Program; and recognizing this ordinance to have an accelerated effective date.

### Discussion

Over the last three years the City has allocated funds for services for unhoused residents through several ordinances. To ensure success of the City's Extreme Weather Program, the Housing and Community Development Department is seeking to provide additional funding to increase the capacity of the department and its partner agencies to provide services to the unhoused under the Extreme Weather Program. This program would use a combination of funds, including existing funds rolled forward from FY23's cold weather plan, funds from the Contingent appropriation of the General Fund, and proceeds from the Marijuana Sales Tax Fund.

This legislation also directs the City Manager to report back to City Council within thirty days with a report on the implementation of the Kansas City Extreme Weather Plan for 2023-2024.
