Executive Summary

Reducing Contingent Appropriation in the amount of \$1,500,000.00 in the Capital Improvements Fund; appropriating that amount to the Stadium Dr Streetscape - E 31st to Raytown Rd project; designating requisitioning authority; and recognizing this ordinance as having an accelerated effective date.

Discussion

This ordinance reallocates \$1,500,000.00 from the Contingent Appropriation account in the Capital Improvements Fund to support the Stadium Dr Streetscape - E 31st to Raytown Rd project. The project is considered important due to Kansas City's role as a host city for the 2026 FIFA World Cup. Infrastructure improvements such as this bridge widening are essential for efficient transportation for both residents and visitors. Use of contingency funds is permissible under Section 2-1954.(f)(6) of the City's Code of Ordinances.
