ORDINANCE NO. 150542

Approving the plat of MO-KAN Teamsters Apprenticeship Training Facility First Plat, an addition in Jackson County, Missouri; accepting various easements; vacating a portion of certain streets; and authorizing the City Clerk to record this ordinance and attached documents. (SD1460)

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the plat of MO-KAN Teamsters Apprenticeship Training Facility First Plat, a subdivision in Jackson County, Missouri, a true and correct copy of which is attached hereto and incorporated herein by reference, is hereby approved.

Section 2. That the plat granting and reserving unto Kansas City an easement and license or right to locate, construct, operate and maintain facilities including, but not limited to, water, gas, sewerage, telephone, cable TV, surface drainage, underground conduits, pad mounted transformers, service pedestals, any and all of them upon, over, under and along the strips of land outlined and designated on the plat by the words utility easement or U/E be and the same are hereby accepted and where other easements are outlined and designated on the plat for a particular purpose, be and the same are hereby accepted for the purpose as therein set out.

Section 3. That the portions of Marsh Avenue, North Avenue, Kentucky Avenue, Wallace Avenue, and Booth Avenue which are identified on the plat as right of way "to be vacated by this plat," are hereby vacated because the Council finds that no private rights will be unreasonably injured or endangered by these vacations and that the public will suffer no unreasonable loss or inconvenience thereby. Utility rights are being retained. These vacations do not become effective until the final plat is recorded.
