WHEREAS, the City sought to provide non-profit operating and capacity building assistance, as well as supportive housing services, including homeless prevention and housing counseling, capacity building, eligible operating costs, and administration; and

WHEREAS, on April 30, 2024, the City, through the General Services Department, Procurement Services Division on behalf of the Housing and Community Development Department, requested proposals to provide a non-congregate, low-barrier shelter facility to assist unsheltered families and individuals within our community for qualified populations associated with the HOME ARP Allocation Plan as approved by the Department of Housing and Urban Development (HUD); and

WHEREAS, on July 22, 2024, the evaluation committee recommended the proposal of Hope Faith Ministries, Inc., dba Hope Faith-Homeless Assistance Campus and Care Beyond The Boulevard pursuant to

WHEREAS, any negotiations and/or executed contract shall include 1) renovation of an existing homeless serving space so that portion of the building can be used as non-congregate, low-barrier shelter; 2) 24/7 operation of the shelter with case management/services; and 3) capacity expansion through a jobs program for homeless individuals and the addition of a fundraising professional for sustainability; NOW, THEREFORE,

#### BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That the City Manager is hereby authorized to engage in contract negotiations with Hope Faith-Homeless Assistance Campus to provide a non-congregate, low-barrier shelter facility and Care Beyond The Boulevard for ancillary services to assist unsheltered families and individuals using previously-appropriated HOME ARP funds under an RFP.

#### **BACKGROUND AND PURPOSE**

The General Services Department, Procurement Services Division on behalf of the Housing and Community Development Department requested proposals to provide a Non-Congregate, Low Barrier Shelter facility to assist unsheltered families and individuals within our community for qualified populations associated with the HOME ARP Allocation Plan as approved by the Department of Housing and Urban Development (HUD). In addition, the City of Kansas City will be providing non-profit operating and capacity building assistance as well as supportive housing services. Supportive services include homeless prevention and housing counseling. Also included is Capacity Building, Eligible Operating Costs, and Administration.

#### **MWBE GOALS**

All \$300,000+ proposals must adhere to the MBE/WBE compliance goals established by City Code

and federal regulations. The mandatory Housing Department (CDBG/HOME) goals (established by CREO) in their totality must meet the following:

a. Construction MBE: 15% WBE: 15%

b. Design/Consulting MBE: 13% WBE: 13%

c. Facility renovation/Tenant Upgrades/Maintenance MBE: 11% WBE: 11%

d. Professional MBE: 14% WBE: 14%

The awarded supplier will work with CREO in best faith to meet the published MWBE goals depending on the final scope of the contract.

#### **SOLICITATION PROCESS**

The intent of this Request for Proposal, EV3180Aa, was to solicit proposals for HOME-ARP 2023 Non-Congregate Shelter, Supportive Services, Non-Profit Operating & Capacity Building Program. The Procurement Services Division and the Housing and Community Development Department worked together throughout the entire process.

#### Solicitation Events:



#### **AWARD AND EVALUATION PROCESS**

RFP closed on May 30, 2024, and twelve proposals were received. The responding firms were Care Beyond the Boulevard, Creative Innovation, Greater Kansas City Housing Information Center, Guadalupe centers, Hope Faith Homeless Assistance Campus, Lean on Me Ministries, Legal Aid of Western Missouri, Metro Lutheran Ministry, Newhouse, Our Spot KC, Reconciliation Services, and reStart Inc.

The Evaluation Committee consisted of Blaine Proctor, Dion Lewis, and L'eon Romanazzi (Housing Dept). Councilwoman Melissa Robinson, Reid Day (Mayor's Office) were advisors.

Of the twelve proposals, the following firms were selected for short-list presentations on the shelter portion of the RFP: Hope Faith Homeless Assistance Campus and reStart Inc. the following suppliers were short-listed for further review on the non-shelter portion of the RFP: Care Beyond the Boulevard, Guadelupe Center, Legal Aid, Metro Lutheran Ministry, and Reconciliation Services.

The remaining proposals were rejected for either not meeting mandatory requirements of the RFP or unfavorable provisions in their responses.

The Evaluation Committee met on July 22, 2024 to determine a final award.

#### RECOMMENDATION/SCORING SUMMARY

Agency: HopeFaith Homeless Assistance Campus

Result: This committee recommends further negotiations for the shelter portion of the RFP.

Reason: Agency's proposal is to create low barrier shelter beds, which is the primary focus of the HOME ARP application, and is the biggest infrastructure need in the homeless service space. Because shelter is the most expensive intervention in the homeless service world, it is the recommendation of this committee to award the supplier's entire requested amount.

Agency: Care Beyond the Boulevard (CBB)

Result: This committee recommends further negotiations for the non-shelter portion of the RFP.

Reason: This agency is creating medical respite beds, it is the recommendation of this committee to award a partial amount of the supplier's requested amount for non-shelter services.

### **APPROVAL**

The recommendation award for this RFP will be based on the suppliers listed above. We will not have a final determination until the negotiations are completed. The negotiated contracts will be submitted back to City Council for approval prior to execution.

Per the HUD requirements, the contracts can be expended through September 30, 2030. The contracts will start upon City Council approval in late 2024. The pricing will be firm and fixed and the Housing and Community Development Department has verified funding for this project.

### **Executive Summary**

Authorizing the City Manager to engage in contract negotiations with Hope Faith-Homeless Assistance Campus to provide a non-congregate, low-barrier shelter facility and Care Beyond The Boulevard for ancillary services to assist unsheltered families and individuals using previously-appropriated HOME ARP funds under an RFP.

### **Discussion**

Emergency shelter and other crisis housing (shelters, interim housing, motel vouchers) play a critical role in our system's response to homelessness. Emergency shelters will always be necessary as there will be always be people dislodged from housing who will need temporary accommodation.

If every person regardless of circumstance needs a bed to sleep in, then every community needs some form of low-barrier shelter, especially when people are living in encampments, on the street or other places not meant for human habitation.

The lack of low-barrier emergency shelter leads individuals to create or seek "shelter" in encampments, which promote trafficking, public health concerns, violence, costly clean-up efforts, and more. The current high barrier shelter system leaves a portion of the population to seek shelter outside. Low Barrier shelter fills that gap.

A reduction in cost may occur as a chronically homeless person costs the taxpayer an average of \$35,578 per year equivalent to 49.5% when people experiencing homelessness are connected to appropriate housing. Shelters provide an access point for chronically homeless folks to connect with necessary resources.

- Encourages access to basic needs like hygiene with dignity
- Integrates housing and community
- Makes decisions in collaboration with residents
- Actively engages with guests, encourages housing and promotes hope

Last week, our staff received a request to provide testimony to the City Council's Finance Committee, tomorrow, August 13, 2024, specifically related to the impacts of housing insecurity and homelessness on the Kansas City Public Library, our services, and ability to deliver on our core mission to serve the Kansas City community.

As a former Deputy City and County Manager for the City and County of Broomfield, I highly value our partnership with the City – both our elected officials and city staff – and wanted to ensure you had a copy of the statement that will be included as part of tomorrow's testimony by Beth Hill, Community Resource Manager.

#### Kansas City Public Library statement on housing insecurity

The Kansas City Public Library serves all in the community, increasingly serving those facing the most pressing challenges, including housing insecurity. Each day, our libraries offer refuge and information individuals need who are seeking basic human needs – needs that a low barrier shelter can offer---a place to sleep, food, access to restrooms or bathing facilities, or simply safety. Interactions between patrons and Library staff continue to reveal the harsh realities of housing instability, affecting individuals and families, and our libraries and our ability to deliver on our mission.

Currently, the Library dedicates significant staff time and financial resources to address the immediate needs of our unhoused patrons. As we all know, even the most dedicated of public servants feel the emotional strain when their assistance can only do so much for someone in need. And while we remain committed to being a partner in this work, it highlights the broader, more pressing issue: our community's lack of sufficient resources. It is a burden that cannot be sustained.

A low-barrier shelter would be transformative for our community, offering safe sleep, access to food, hygiene products, and essential holistic support services. The resources are not just necessary; they are urgent. Without them, the strain on the Library and other community partners will only continue to grow, further exacerbating challenges of safety and well-being for both unhoused individuals and the community at large.

A low-barrier shelter is essential, not just for the Library and its ability to deliver on our core mission for all, but for the health and well-being of our entire community.

#### **Supporting Statistics:**

- Over 4,500 interactions with unhoused individuals at KCPL in 2024, averaging 600 per month.
- 1,598 food-related interactions this year, averaging 228 per month.
- 886 personal care interactions, including hygiene and clothing, averaging 126 per month.
- 215 housing/shelter-related interactions, averaging 31 per month.

Calling an election on November 5, 2024, for the purpose of renewing a one-quarter cent capital improvement – public safety sales tax for 32 years; setting forth the ballot language to be used; directing the City Clerk to provide notice of election; amending Chapter 68, Article VII, Code of Ordinances by repealing existing Section 68-447 and enacting in lieu thereof a section of like number and subject matter contingent upon voter approval; directing the City Clerk to provide notice to the Director of Revenue if the sales tax question is passed by the voters; declaring the intent of the City Council to maintain the currently imposed capital improvement – public safety sales tax should the sales tax question not be approved by the voters; and recognizing this ordinance as having an accelerated effective date.

WHEREAS, in an election held on November 2, 2010, the qualified voters of the City previously approved the extension of a sales tax authorized by Section 94.577, RSMo., to expire on June 30, 2026; and

WHEREAS, the City finds it necessary to construct and maintain a municipal detention center, privately operated substance abuse treatment and acute mental health services facility, low barrier shelter, and transitional housing for those individuals experiencing homelessness (the "Project"); and

WHEREAS, the City anticipates that the cost of the Project will be funded with the issuance of special obligation bonds ("Bonds") in Spring 2026, with the payment of scheduled debt service on the Bonds to be made by annual appropriation of monies from the renewed sales tax; and

WHEREAS, the City desires to submit to the voters the question of whether to renew the capital improvements – public safety sales tax prior to its expiration in order to establish a dedicated source of funding for the Project; and

WHEREAS, should the qualified voters of the City elect not to renew the capital improvements – public safety sales tax, the City intends to maintain the currently imposed tax, which shall expire on June 30, 2026; NOW THEREFORE

BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. That an election is called on November 5, 2024 for the purpose of submitting to the qualified voters of Kansas City, Missouri the question of renewing a capital improvement sales tax authorized by Section 94.577, Revised Statutes of Missouri.

Section 2. The ballot title for the sales tax proposition shall be:

That following the passage of this ordinance, the City Clerk shall deliver certified copies of this ordinance and notice of election to the Clerk of Cass County, Board of Election Commissioners of Clay County, Board of Election Commissioners of Kansas City, and Board of Election Commissioners of Platte County, not later than August 27, 2024, which shall be the authority of each election authority of the City to submit the amendment to the electors of Kansas City and to give public notice as provided by law.

Section 8. That this ordinance, calling for an election and providing for the submission of a proposal to the people of Kansas City, Missouri, is hereby recognized as an ordinance with an accelerated effective date within the meaning of Section 503(a)(3)(A) of the Charter, and as such shall become effective immediately following approval by the Mayor or five days after passage if no action is taken by the Mayor to approve or veto the ordinance.

#### **BACKGROUND AND PURPOSE**

The General Services Department, Procurement Services Division on behalf of the Housing and Community Development Department requested proposals to provide a Non-Congregate, Low Barrier Shelter facility to assist unsheltered families and individuals within our community for qualified populations associated with the HOME ARP Allocation Plan as approved by the Department of Housing and Urban Development (HUD). In addition, the City of Kansas City will be providing non-profit operating and capacity building assistance as well as supportive housing services. Supportive services include homeless prevention and housing counseling. Also included is Capacity Building, Eligible Operating Costs, and Administration.

### **MWBE GOALS**

All \$300,000+ proposals must adhere to the MBE/WBE compliance goals established by City Code

and federal regulations. The mandatory Housing Department (CDBG/HOME) goals (established by CREO) in their totality must meet the following:

a. Construction MBE: 15% WBE: 15%

b. Design/Consulting MBE: 13% WBE: 13%

c. Facility renovation/Tenant Upgrades/Maintenance MBE: 11% WBE: 11%

d. Professional MBE: 14% WBE: 14%

The awarded supplier will work with CREO in best faith to meet the published MWBE goals depending on the final scope of the contract.

#### **SOLICITATION PROCESS**

The intent of this Request for Proposal, EV3180Aa, was to solicit proposals for HOME-ARP 2023 Non-Congregate Shelter, Supportive Services, Non-Profit Operating & Capacity Building Program. The Procurement Services Division and the Housing and Community Development Department worked together throughout the entire process.

### **AWARD AND EVALUATION PROCESS**

RFP closed on May 30, 2024, and twelve proposals were received. The responding firms were Care Beyond the Boulevard, Creative Innovation, Greater Kansas City Housing Information Center, Guadalupe centers, Hope Faith Homeless Assistance Campus, Lean on Me Ministries, Legal Aid of Western Missouri, Metro Lutheran Ministry, Newhouse, Our Spot KC, Reconciliation Services, and reStart Inc.

The Evaluation Committee consisted of Blaine Proctor, Dion Lewis, and L'eon Romanazzi (Housing Dept). Councilwoman Melissa Robinson, Reid Day (Mayor's Office) were advisors.

Of the twelve proposals, the following firms were selected for short-list presentations on the shelter portion of the RFP: Hope Faith Homeless Assistance Campus and reStart Inc. the following suppliers were short-listed for further review on the non-shelter portion of the RFP: Care Beyond the Boulevard, Guadelupe Center, Legal Aid, Metro Lutheran Ministry, and Reconciliation Services.

The remaining proposals were rejected for either not meeting mandatory requirements of the RFP or unfavorable provisions in their responses.

The Evaluation Committee met on July 22, 2024 to determine a final award.

#### RECOMMENDATION/SCORING SUMMARY

Agency: HopeFaith Homeless Assistance Campus

Result: This committee recommends further negotiations for the shelter portion of the RFP.

Reason: Agency's proposal is to create low barrier shelter beds, which is the primary focus of the HOME ARP application, and is the biggest infrastructure need in the homeless service space. Because shelter is the most expensive intervention in the homeless service world, it is the recommendation of this committee to award the supplier's entire requested amount.

Agency: Care Beyond the Boulevard (CBB)

Result: This committee recommends further negotiations for the non-shelter portion of the RFP.

Reason: This agency is creating medical respite beds, it is the recommendation of this committee to award a partial amount of the supplier's requested amount for non-shelter services.

### **APPROVAL**

The recommendation award for this RFP will be based on the suppliers listed above. We will not have a final determination until the negotiations are completed. The negotiated contracts will be submitted back to City Council for approval prior to execution.

Per the HUD requirements, the contracts can be expended through September 30, 2030. The contracts will start upon City Council approval in late 2024. The pricing will be firm and fixed and the Housing and Community Development Department has verified funding for this project.
