This package substantially involves the excavation and placement of a large underground storage basin, with limited opportunity for MBE/WBE engagement.

The second construction package, will involve a larger MBE/WBE participation. The following table sets out the planned levels of MBE and WBE participation and is provided to demonstrate our intention for the project overall, including the prior Phase 1 (Design) activities.

Note that Hz Trucking, Pfefferkorn Engineering & Environmental, Thorne & Sons, Mac's Fence, Rising Construction, Midwest Contracting Services and Wilkerson Crane are subcontractors to Site Rite, who in turn will be subcontracted by Burns & McDonnell Engineering Co., Inc.
