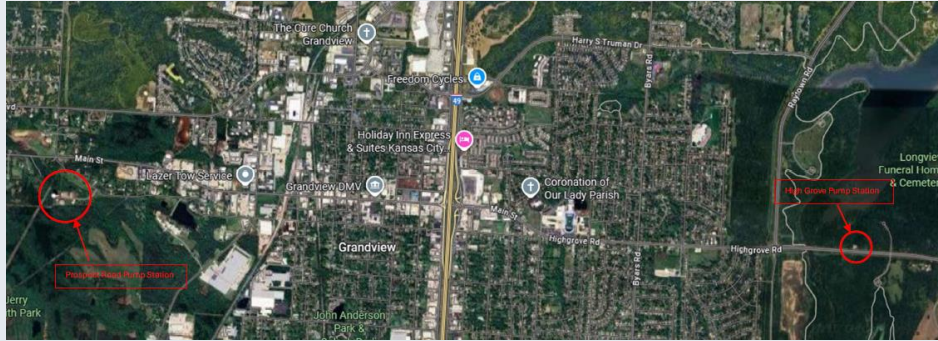

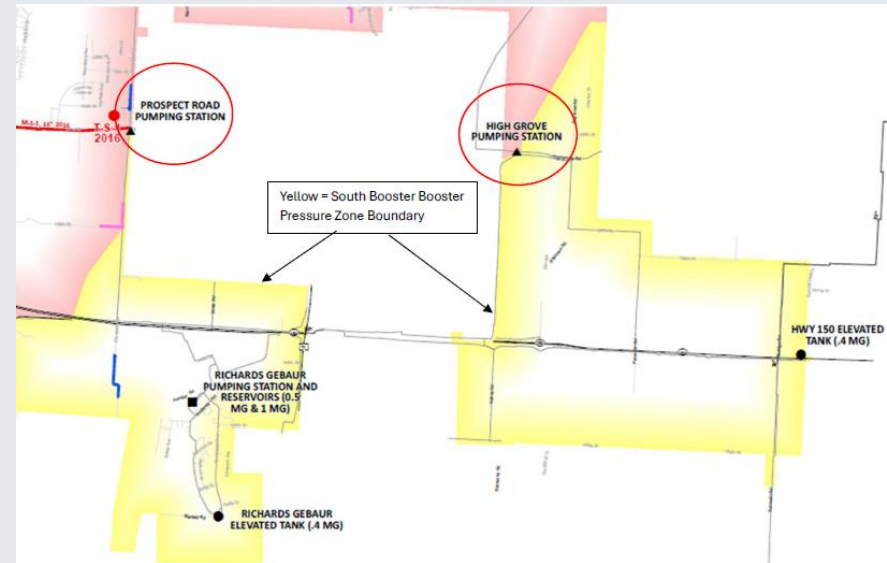

ORDINANCE NO. 250716

Who is Eligible?

Low- to moderate-income households located in Kansas City, Missouri may be eligible.

Eligibility factors may include one of the following:

- Currently receiving WIC, Social Security, Medicaid/Medicare, Retired, Disability, etc., or job impacted by COVID-19
- High water bill or received water bill insert
- Referral from KC Water or Evergy
- Home is in high priority zip code: 64132, 64130, 64128, 64127, 64126, and 64109 (Can be renter or homeowner)
