Executive Summary

Authorizing the Manager of Procurement Services to execute one contract in the amount of \$1,000,000.00 with ReDiscover from previously appropriated funds to operate the Kansas City Assessment and Triage Center (KC-ATC) and provide crisis intervention services for individuals experiencing mental health or substance use emergencies; and recognizing this ordinance as having an accelerated effective date.

Discussion

ReDiscover will provide, facilitate, or coordinate access to Clinical Assessment for each client's behavioral health status including history of symptoms and treatment and engagement with community behavioral health providers. Crisis Intervention and Treatment will be provided for individuals experiencing a mental health or substance abuse crisis. Discharge plans will be developed as well as referrals to the appropriate community behavioral health agencies. Triage slots will be maintained for individuals with substance use disorders and mental illnesses.
