### DESIGN PROFESSIONAL SERVICES AMENDMENT NO. 2

# PROJECT NO. 62190508 – DESIGN AIRPORT DEVELOPMENT DT CHARLES B. WHEELER DOWNTOWN AIRPORT AVIATION DEPARTMENT

This amendment is between KANSAS CITY, MISSOURI, a constitutionally chartered municipal corporation (City), and Crawford, Murphy & Tilly (Design Professional). The parties amend the Agreement entered into on May 5, 2020, as follows:

Sec. 1. Sections Amended. The Agreement is amended as follows:

A. Sec. 2, Paragraph A, Scope of Services, add the following section:

## 9. <u>PRELIMINARY ENGINEERING DESIGN PHASE OF REHABILITATE RUNWAY 3-21 PROJECT</u>

#### A. PROJECT OVERVIEW

This contract will consist of preliminary engineering design phase services for the project to Rehabilitate Runway 3-21 at Charles B. Wheeler Downtown Airport (MKC).

#### B. PRELIMINARY ENGINEERING DESIGN PHASE SERVICES

The intent of the Preliminary Engineering Design Phase is to provide the City of Kansas City Aviation Department a Pavement Evaluation Summary and Rehabilitation Recommendation Report, complete with a Preliminary Engineer's Opinion of Probable Cost for the upcoming Rehabilitate Runway 3-21 Design project. Design services will be completed in accordance with all applicable FAA airport design standards, as amended (e.g. Advisory Circulars, Engineering Briefs, etc.). The following is a summary of the major design phase components to be included as part of the design:

- a. Collection and evaluation of record and as-built drawings
- b. Conduct Kickoff Meeting (including preparation & distribution of meeting agenda and minutes)

- d. Pavement Cores/Geotechnical Investigation and Report (TSi) for Runway 3-21 (24 pavement cores/soil borings)
- e. Non-Destructive Testing (NDT) Analysis and Report (ERI)
- f. CMT Badged-Escort for Testing Subconsultants

#### 3. General Project Items

- a. Tabulation of PCI Survey Data
- b. Pavement Rehabilitation Design (FAARFIELD software)
- c. Life Cycle Cost Analyses of Pavement Rehabilitation Alternatives
- d. Preliminary Quantity Estimate and Preliminary Engineer's Opinion of Probable Cost (OPCC)
- e. Compilation and delivery of "Pavement Evaluation Summary and Rehabilitation Recommendation" draft report
- f. Preliminary Design Review meeting (including preparation of agenda and minutes)
- g. Completion and delivery of "Pavement Evaluation Summary and Rehabilitation Recommendation" final report

Sec. 2. Sections not Amended. All other sections of the Agreement shall remain in full force and effect.

Sec. 3. Authorization. If the amount of the original Agreement plus the amount of any amendments to the original Agreement total over \$400,000.00, then this amendment requires City Council or Park Board authorization. Notwithstanding the foregoing, City Council or Park Board authorization is not required if (1) the total amount of the original Agreement plus the amount of any amendments to the original Agreement are within ten percent (10%) of the maximum amount authorized by the City Councilor the Park Board or (2) a previous ordinance or Resolution authorized amendments without further City Council or Park approval.

Sec. 4. Effectiveness Date. This amendment will become effective when all the parties have signed it. The date this amendment is signed by the last party to sign it will be deemed the date of this amendment.
