The applicant is seeking to detach about 103 acres of land from Kansas City and concurrently annex the land into the City of Belton, MO.

PLAN REVIEW

Overview

Annexation is a process in which land is transferred from one unit of government to another. Commonly, annexations can connect services, increase population and local tax base, or extend planning and zoning authority for the receiving municipality (APA Quick Notes No. 67). The subject case focuses on a de-annexation (a transfer of property) of about 103 acres, from the City of Kansas City, MO to the City of Belton, MO. The property lies on the southern edge of the Kansas City, MO boundaries, directly adjacent to the City of Belton. The annexation will not create a "void" of space within the municipality but an irregular boundary between industrial uses.

The site is located about 6,103.3 feet south from HWY 150. Now named the Eagles' Landing Golf Course (formerly known as the Belton Municipal Golf Course), re-opened in 2007 with several new features. The Eagles' Landing Golf Course website states that an additional 45 tree complexes, two practice greens, an irrigation system, and cart paths were installed including the rehabilitation of all 18 greens on-site and regrading/draining of the fairways. Members of the public pay to use the facilities at the golf course. The City of Belton has no known plans to alter or change the golf course.

Long-Range Planning

Area plans recommend strategies to help realize a community's long-term vision for future growth and stability. These plans focus on land use, housing, public services, community development, and more. The Martin City Area Plan, which corresponds with the subject site, is one of 18 area plans in Kansas City. The Martin City Area Plan does not have specific recommendations about the subject site.

Other

A financial analysis has not been conducted. However, City Staff does not believe that a significant amount of revenue is obtained from publicly owned land, if any.

The City of Belton has reached out to Councilperson Andrea Bough about the subject request. No statements of concern or other inquiries have been sent to Development Management City Staff from Bough's office.

PROFESSIONAL STAFF RECOMMENDATION

City staff recommends **Approval Subject to Conditions** as stated in the corrections, conditions, and recommendations report.
