<p><b>Specific Address</b></p> <p>The Redevelopment Area is generally bounded by US Highway 152 on the north, 1-35 on the east and North Church west and south in Kansas City, Clay County, Missouri.</p> <p><b>Reason For Legislation</b></p> <p>The Twenty-Third Amendment (1) modifies the boundaries of the Redevelopment Area and Redevelopment Project Area N, (2) modifies the description of public improvements described by the Plan, (3) modifies the Budget of Redevelopment Project Costs, (4) modifies the Sources of Funds (5) modifies the Development Schedule and (6) modifies certain exhibits to and sections of the Plan that are in furtherance of the foregoing.
