INITIAL MEETING OF THE BOARD OF DIRECTORS







WHEREAS, the 46th & Wornall Community Improvement District #2 (the "District") is required to adopt an annual budget for the operation of the District;


WHEREAS, the District submitted to the City the proposed annual budget for FYE 4/30/2023, which is attached hereto as Exhibit A; and

BUDGET MESSAGE:

The 46th & Wornall Community Improvement District #1 was formed as a political subdivision of the State of Missouri on July 8, 2020. The District was formed for the purpose of providing revenue sources to assist with and support the financing of the costs of certain public and private improvements that serve the area encompassing the District. The District's sole source of revenue is a 1% sales tax, the collection of which has not yet commenced and will terminate 20 years from the date upon which any sales tax is levied within the District.

NOMINATE SUCCESSOR DIRECTORS






**AUTHORIZE PREPARATION AND SUBMITTAL OF
