Executive Summary

Authorizing a \$6,234,332.30 construction contract with The Havens Construction Company, Inc., for the Sewer Separation: Outfall 054 project; authorizing a maximum expenditure of 6,860,000.00; and authorizing a \$900,000.00 Design Professional Services Amendment No. 2 to Contract 1573 with CDM Smith, Inc. for a total contract amount of \$1,696,756.00

Discussion

Reason for Contract

In 2010, the City of Kansas City, Missouri entered into a Consent Decree with the United States Environmental Protection Agency (EPA) to reduce the volume and frequency of overflows from the City's sewer system. The City's Smart Sewer Program is currently in year 13 of a 25-year implementation period. The purpose of this project is to separate approximately 35 acres of the City's combined sewer system near E. 17th St and White Avenue, integrate green infrastructure, and rehabilitate the existing sewer system to eliminate typical year combined sewer overflows at Outfall 054 located within the Lower Blue River Basin.

Construction Contract Description

The scope of work to be provided under the construction contract includes 3,063 linear feet (LF) of new storm sewer construction ranging in diameter from 15-inches to 24-inches with associated manholes and curb inlets, a bioretention basin at E. 17th Street and Belmont Avenue, two underground stormwater storage facilities, rehabilitation of 7,256 LF of sewer mains ranging in diameter from 8-inches through 30-inches, total pipe replacement of 1,321 LF of sewer main ranging in diameter from 8-inches through 15-inches, and repairs to 45 manholes and 131 service laterals. The amount of the proposed construction contract is \$6,234,332.30 plus a contingency amount of \$625,667.70 for a total of \$6,860,000.00.

The term of this project will be 480 calendar days.

Solicitation

The Sewer Separation: Outfall 054 was advertised in accordance with the City's requirements on February 7th, 2023, and bids were opened on March 7th, 2023, with two (2) bidders responding.

Awardee/Subcontracting Participation

The Havens Construction Company, Inc. submitted the lowest, responsible, and responsive bid of \$6,234,332.30, with subcontracting participation of 10% MBE and 10% WBE.

Other Bidders/Subcontracting Participation

Infrastructure Solutions, LLC was the only other bidder on this project. They submitted a bid in the amount of \$6,961,800.00, with subcontracting participation of 10% MBE and 10% WBE.

Estimated Opinion of Probable Construction Costs

The Engineer's Opinion of Probable Construction Cost was \$8,190,244.00.

<u>Design Professional Services Contract Amendment Description</u>

Proposed Amendment No. 2 to Design Professional Services Contract Number 1573 in the amount of \$900,000.00, for a total contract amount of \$1,698,756.00 will provide for construction phase services including project management and administration services, construction office and field support services, and resident project representative services.

Prior Legislation

City Council passed Ordinance No. 200479 on July 16, 2020, authorizing a \$490,000 Design Professional Services Contract Number 1573 with CDM Smith, Inc. for conceptual and preliminary design of the Sewer Separation: Outfall 054 project.

Amendment No. 1 to this contract was approved by the City on June 16, 2021 in the amount of \$306,756.00 for final design and preparation of construction contract documents.

4. Does the ordinance/resolution include Civil Rights antidiscrimination requirements in compliance with the Code of Ordinances (Chapter 38, titled "Civil Rights")?

Yes. Goals for the construction contract were approved by the Civil Rights and Equal Opportunity (CREO KC) Department under the Annual Goal Program at 10% MBE and 10% WBE on 08/02/2022.

The goals on the design professional services contract were approved by the Human Relations Department (now known as CREO KC) on July 15, 2019 at 15% MBE and 10% WBE and will remain unchanged with this proposed Amendment No. 2.
