### 2023 Charter Review Commission

Charter Section 1212 provides, "The Mayor shall appoint a Charter Review Commission no less than once every ten years for the purpose of reviewing the terms and operation of the City Charter. The Commission may make recommendations to the Mayor and City Council for amendments to the City Charter or may recommend no changes."

### Overview of recommendations

- Centralize filing locations and randomize ballot order
- Standardizing petition thresholds
- Declaring any candidate receiving 2/3rds of the vote in the primary as elected without a general election
- Providing additional structure for future Charter Review Commissions

<u>Issues suggested for further study</u>: number of districts, voter education efforts, ranked-choice voting



## Centralized Filing System and Random Ballot Order

#### **CURRENT STATE**

- Nomination petitions may be filed with the City Clerk and local election authorities
- Ballot order determined by submission order

#### **RECOMMENDATION**

- Centralize filing nomination petitions with the City Clerk
- Establish random ballot ordering after petitions are received
- Mirror this process for recall petitions



### **Standardizing Petition Thresholds**

#### **CURRENT STATE**

- Number of required signatures is set as a percentage of votes cast in last Mayoral election:
  - 5% for initiative petitions
  - 10% for referendum petitions
  - 20% for recall petitions

#### **RECOMMENDATION**

- Number of required signatures is set as EITHER a percentage of votes cast in last Mayoral election OR the following static thresholds, whichever is higher:
  - 4,000 for initiative petitions
  - 7,000 for referendum petitions
  - 18,000 for Mayor and At-Large recall
  - 3,000 for In-District Recall
- Increase recall percentage threshold to 25% of votes cast in last Mayoral election



### **Voting Methods Update**

#### **CURRENT STATE**

 Primary and general elections, with top two advancing to general from primary, regardless of how large a majority of votes any candidate receives

#### **RECOMMENDATION**

- Any candidate receiving at least 2/3rds of votes cast shall be declared elected and shall not have a general election
- Races in which no candidate received at least 2/3rds of votes cast would move to a runoff in the general election
- Write-ins remain permissible in the primary election



### **Charter Review Commission Guidelines**

### **CURRENT STATE**

 Commission shall be appointed to review terms and operations of the City Charter

#### **RECOMMENDATION**

 Establish number of Commissioners, minimum length of time to convene, require public meetings in each Council district and at least two weekend meetings, and that the City Clerk shall maintain a copy of Commission's report or correspondence



# Additional Recommendations That Do Not Require Charter Revisions

- Specialized study of Council Districts and composition of At-Large Council seats
- Increased efforts to drive voter education and outreach, including engaging youth and creating nonpartisan Ballot Information Booklet
- Continued study and public engagement regarding possibility of adopting Ranked Choice Voting method
