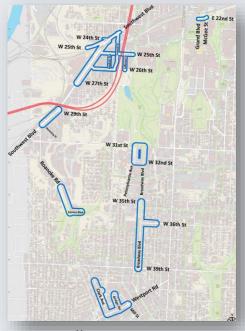

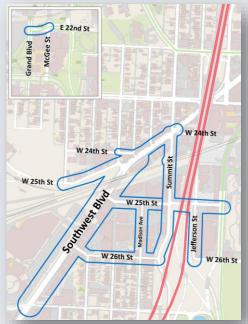
Amendment No. 2
