

FINANCE, GOVERNANCE AND PUBLIC SAFETY COMMITTEE

190683 - Repealing Ordinance 190443 that authorized a professional services contract related to the programming, design and reconstruction of the Auditorium Plaza Garage and Barney Allis Plaza Event Space and estimated and appropriated funds in the amount of \$1,350,000.00.

200278 - Directing the City Manager to complete a study of downtown parking capacity to determine whether current and future downtown parking needs can be addressed by renovation of existing facilities, through new construction, or acquisition and arrangements with already-existing garage facilities.

200336 - Authorizing the City Manager to renew a Limited Term Contract in the amount of \$48,000.00 to provide administrative support needed to maintain economic development projects and outreach.

200421 - Amending Article VII, entitled "Sales Taxes", of Chapter 68, Code of Ordinances, entitled "Taxation", by creating a new Section 68-472 relating to the allocation of the Public Mass Transportation Sales Tax.

200908 - Appointing Justice T. Horn as a governance advisor to the Mayor and City Council for the newly established Kansas City Lesbian, Gay, Bisexual, Trans and Queer Commission to assist them in appointing board members to the Commission who are broadly reflective of and sensitive to the needs of the LGBTQ community's diverse population.

220130 - Appropriating \$500,000.00 from the Unappropriated Fund Balance of the General Fund to provide funds to certain organizations to support re-entry into communities, food security and mental health, and small business growth; and authorizing the execution of agreements.

190991 - Approving an Industrial Development Plan for American Century Services, LLC, for the purpose of making renovations/leasehold improvements to the commercial buildings located at 4400 and 4500 Main Street, Kansas City, Missouri, and for the purchase of machinery and fixtures; authorizing and approving various agreements for the purpose of setting forth covenants, agreements and obligations of the City and American Century Services, LLC; authorizing the issuance of taxable industrial revenue bonds in a maximum aggregate principal amount not to exceed \$86,338,000.00; authorizing and approving certain other documents; and authorizing certain other actions in connection with the issuance of said bonds.

220693 - Amending Chapter 62, Article II of the Code of Ordinances entitled Solid Waste, by repealing Section 62-41, "Residential refuse collection - Eligibility," and enacting in lieu thereof a new section of like number and subject matter which amends residents eligible for residential refuse collection.
