## **Executive Summary**

Authorizing the acceptance of a \$1,677,279.29 grant from the United States Department of Homeland Security Fiscal Year (FY) 2022 Assistance to Firefighters Grant (AFG) Program; and including a City match of \$167,727.93, or ten (10%) percent of the Federal contribution bringing the total cost of Federal and Non-federal funding to \$1,845,007.22; estimating revenue in the amount of \$1,677,279.29 in the General Grants Fund; appropriating \$1,677,279.29 to the Assistance to Firefighter Grant (AFG) Program account in the General Grants Fund; designating requisitioning authority; and recognizing this ordinance as having an accelerated effective date.

#### **Discussion**

The United States Department of Homeland Security Assistance to Firefighters Grant (AFG) Program is covering up to 90% of the cost for the purchase of Fire Equipment that would need to be purchase in this Fiscal Year to maintain maintain the department operationaly in provideding Emergency Services to the citizens and vistors within the metropolitan region of Kanasas City Missouri. This grant would assist in the purchase of 2,088 assorted fire attack hose sizes, 510 multiple types of nozzle's, 82 Automated External Defibrillators (AEDs) BLS Level, and access to an online training platform to implement NFPA 1962 compliance software for inventory and annual testing records as a part of our ESO Asset Management contract.
