Declaring it necessary to change and re-establish the grades on portions of NE 48th Street, as well as to open, establish and dedicate Street Right of Way for Project Number 89008895, "NE 48th Street Improvements", in Kansas City, Clay County, Missouri; and directing the City Clerk to cause a notice to be published as provided for herein; and directing the City Clerk to cause this ordinance to be recorded in the Office of the Recorder of Deeds for Kansas City, Clay County, Missouri.

Discussion

For the public good, it is necessary to open, establish and dedicate Street Right of Way for Project Number 89008895, "N.E. 48th Street Improvements", all in Kansas City, Clay County, Missouri.

It is also necessary that the grades on Northeast 48th Street in the area between Interstate 435 and N Wallace Drive, all being in Kansas City, Clay County, Missouri, be changed and re-established.

Said improvements shall be of the nature described and specified in accordance with, the plans and specifications for Project No. 89008895 which is on file in the Office of the Director of Public Works.
