Additional Information:  Smarte Carte, Inc. provides automated (self-service) luggage cart services within the Arrivals Level - Baggage Claim area, both domestic and international, and other areas as the Director may determine as essential and beneficial, for the new single terminal building at Kansas City International Airport. This Agreement provides dispensing equipment and luggage carts at "no cost" to City as well as a nominal revenue.  This 1st Amendment provides for 1) two new outside luggage cart dispensers, one at the Commercial Lane and another at the Departure Level, 2) 50 sf lease of storage space within the Terminal, and 3) the addition of CREO Civil Rights and Wage Assurances to the Agreement.  Concessionaire shall pay to the City a Monthly Concession Fee based upon an agreed percentage (14.5%) of the total gross revenues received by the concessionaire, and as well provide an important and useful amenity/service to the traveling public. Provided with this Goals Request is the Original Concession Agreement Contract #6222090042, dated March 1, 2013. There is not an attached "Estimated Cost Breakdown" as this is a revenue generating concession.
