## **Executive Summary**

Appropriating \$759,994 from the Unappropriated Fund Balance of the Aviation Fund; and authorizing a First Amendment with Schindler Elevator Corporation for additional labor and overtime rate adjustments at Kansas City International Airport.

## Discussion

This 1<sup>st</sup> Amendment to original Agreement # 6222100043 adds three months of labor and allows for overtime. The Amendment also allows contractor to procure spare parts not to exceed 10% of the contact value, updates required Federal language of Part III and adds CREO Wage Assurances and Civil Rights as Attachment H.

The original Contract began January 15, 2023 and shall end no later than April 30, 2028. The maximum amount that City shall pay Contractor shall now not exceed eleven million three-hundred fifteen thousand two-hundred thirty-seven dollars eighty cents (\$11,315,237,80).
