Executive Summary

Repealing Chapter 4, Article II, Code of Ordinances, Chapter 12, Article IV, Code of Ordinances, and Sections 40-95, 40-97, 40-107, 40-355, 40-362, and 40-363, Code of Ordinances.

Discussion

The City of Kansas City imposes conduct regulations and business license fees on various professions and occupations for the privilege of engaging in business within the City. Through Ordinance No. 230395, the City Council established the Small Business Task Force with the goal of developing a strategic plan to guide the City in the equitable development, funding, and retention of small businesses within the City. The Small Business Task Force, in conjunction with the City Council, has identified several regulations and specialty license fees that are considered overly burdensome to small businesses in the City. The City Council desires to repeal several conduct regulating ordinances and business license fees to decrease the regulatory burden on small businesses and reduce clutter within the City's Code of Ordinances.
