Annual Rate Setting Ordinances

Ordinance No. 250169

Setting the rates for the trafficway maintenance tax, the park and boulevard maintenance tax, and the boulevard and parkways front foot assessment at \$0.00 for FY 2025-26.

- **Required to set at zero following passage of the 1/2 cent Sales Tax authorized by voters in 2012 for the purpose of providing for the maintenance and operations of local parks, parkways, boulevards and community centers**
- **Board of Parks and Recreation Commissioners passed Resolution No. 32726 on January 28, 2025, recommending to the City Council that rates be set at \$0.00 for the park and boulevard maintenance tax and the boulevards and parkways front foot assessment**

Ordinance No. 250170

Levying taxes for FY 2025-26 for the General Revenue, Health, General Debt and Interest and Museum Special Revenue Funds.

- **Levying taxes to support property tax revenue generation in the FY 2025-26 Submitted Budget**

GO Bond Appropriation Ordinances

Ordinance No. 250173 and 250174

GO Bond Plan is previously approved with the annual update to five-year financial plans in the Citywide Business Plan

- **Capital planning best practices include a multi-year capital plan. Project scopes are complex requiring advance design and possible right-of-way considerations**
 - **Approved pursuant to Committee Substitute for Ordinance No. 240857 passed on October 31, 2024**
 - **Ordinance 250173 and 250174 authorizes funding of the previously approved FY 2025-26 projects**
 - **Detailed in the Capital and Debt Section of the Budget Document**

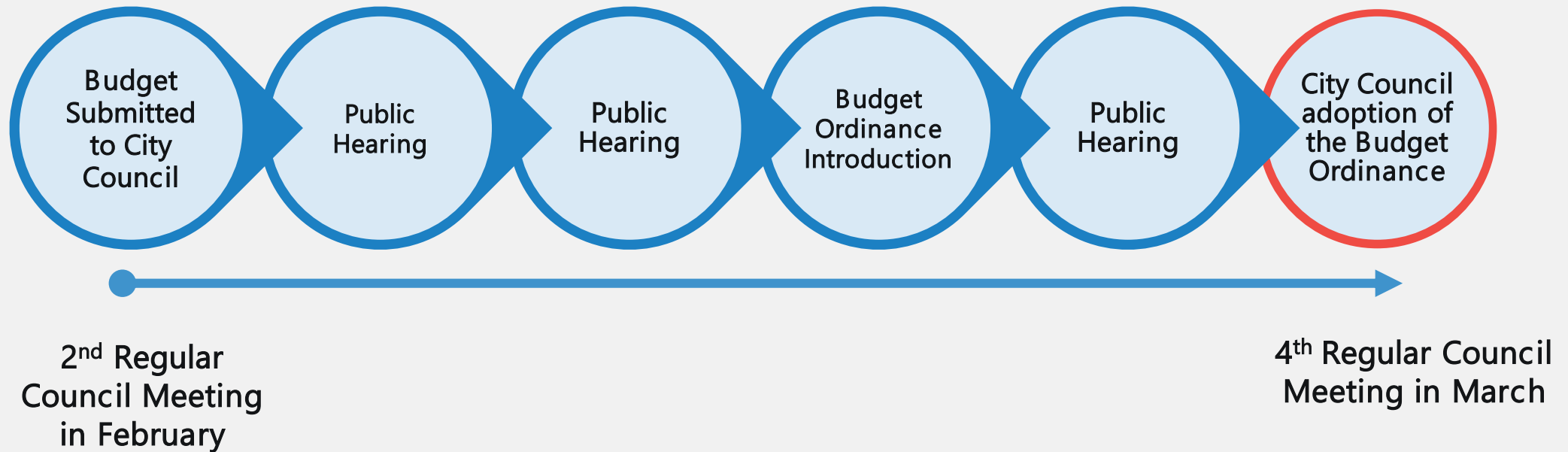
- Ordinance 160951- \$800 million over 20 years
- Question 1
 - Roads, Bridges, Sidewalks- \$600 million
 - Remaining- \$356.4 million
- Question 2
 - Flood Control- \$150 million
 - Remaining- \$99.06 million
- Question 3
 - Public Buildings- \$50 million
 - Remaining- \$6.47 million
- Capital Asset Rating System used to determine highest needed projects - Ord 220484

Ordinance No. 250174 - GO Bond 2022

- Ordinance No. 220663- \$175 million over 5 years
- Question 1- \$125 million over 5 years
 - Parks - \$80 million – Ordinance No. 220918
 - \$60 million to be divided equally between Council districts (\$55 million remaining)
 - \$20 million Citywide Parks use (all allocated)
 - Conventions - \$45 million (all allocated)
- Question 2
 - Housing - \$50 million
 - Remaining - \$25 million (allocated at \$12.5 million a year)

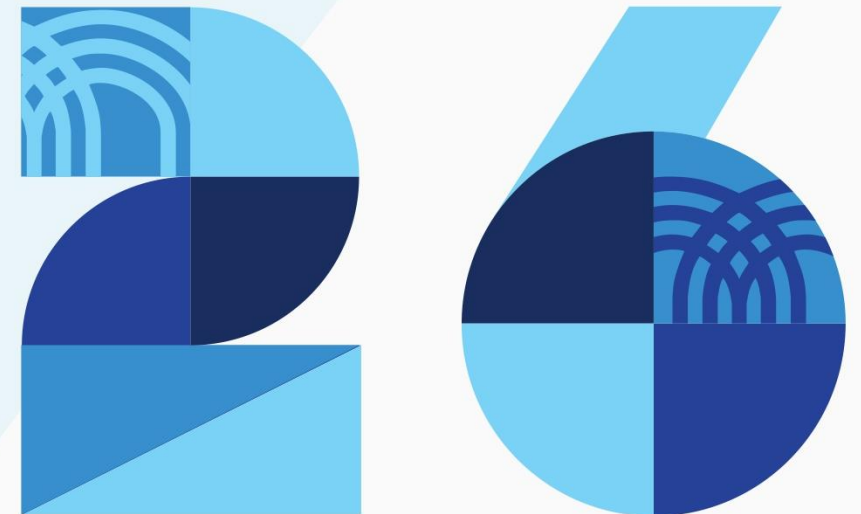

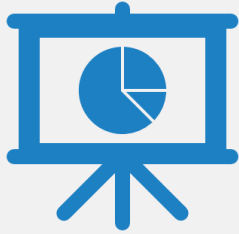

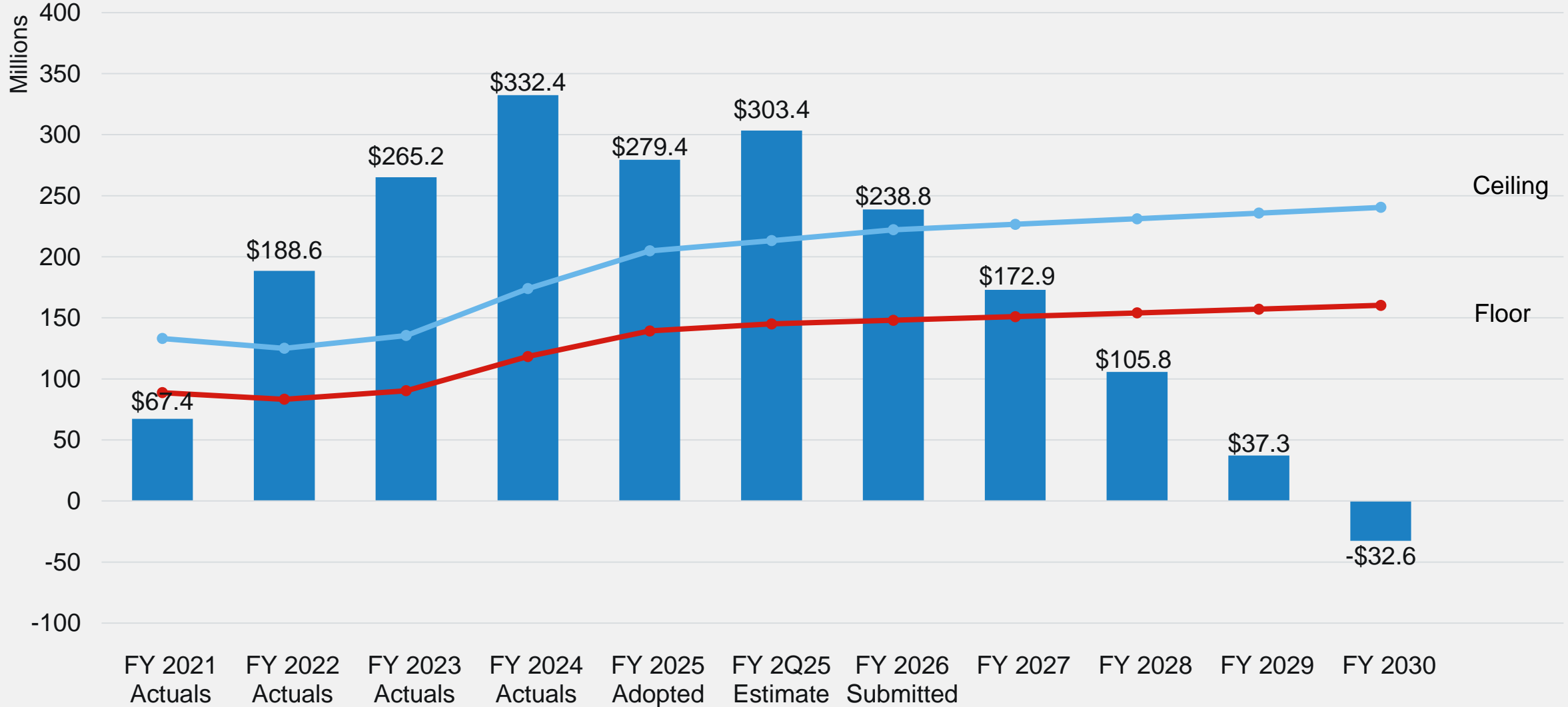

Fiscal Sustainability Remains Critical Priority

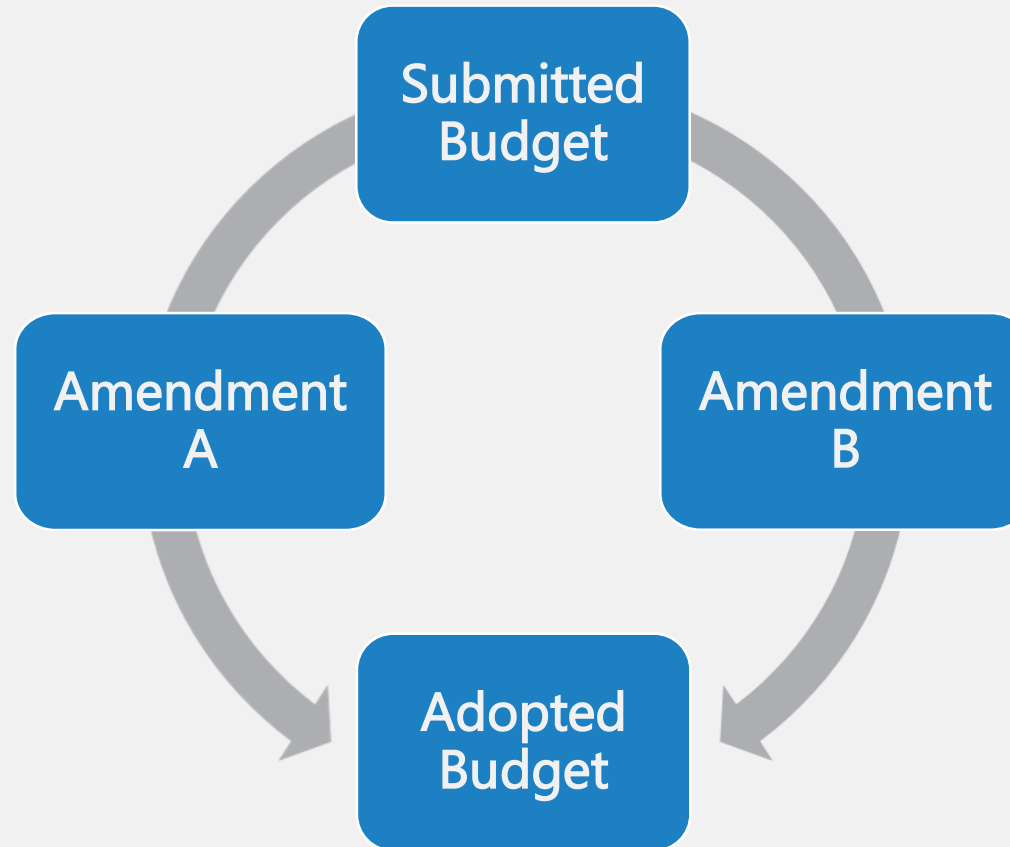
General Fund Structural Imbalance and Path Forward to Sustainability
