Greetings. I was able to listen to the meeting of the Mayor's homeless task on the 17th but was not allowed to participate. The conversation between the task force members chaired by Council woman Ryana Parks-Shaw had to do with there not being a quorum therefore no decisions could be made. There was discussion put forth by some of those members of the task force who were present to include a lady with the health department who discussed doing mappings, survey's and some other things that would take 120 days. Mappings??? We're less than 90 days away from the beginning of cold weather!! We don't have 120 or 180 days!! We have been involved with this for almost 8 months and I heard Council woman Parks-Shaw say on more than one occasion there is a wrap around service plan in place. She has not spoken to me or the team who wrote the plan unless she has another wrap around service plan in place. Consolidated Social Work Services Inc. was asked by the City Manager to write the Wrap Around Service Plan and we did that. I believe it was in April that we decided our Mission. "A roof for everyone who needs a roof. Housing first". What happened to Committee Substitute For resolution NO. 190858, AS Amended and Resolution No. 210059.? The U.S. Inter-agency Council on Homelssness released a report of their meeting July 13, 2021 about the U.S. inter-agency Council on Homelessness's (USICH) first meeting under newly elected leadership to discuss the Biden-Harris administration's vision for the Federal Strategic Plan to Prevent AND end Homelessness, how to maximize the impact of the American Rescue Plan, and the economic and MORAL obligation to prevent evictions. It was led by the new chair, Housing and Urban Development (HUD) Secretary Marcia Fudge, and vice chair, Veterans Affairs (VA) Denis McDonough. The coordinator for the State of Missouri is Beverley Ebersold, Director of National Initiatives, Based in Detroit, Mi. (202) 754-1585. beverlev.ebersold@usich.gov. Billions of dollars have been provided to reduce homelessness and increase housing stability across the country. Over 70,000 Emergency Housing Vouchers have been given out. Why haven' these vouchers been processed? Did Kansas City not receive any vouchers?. Why are housing applications not being processed? And please don't tell us it's because of lack of staff. I have a copy of budgets. Is anyone talking to any one else about solutions?? Things are in horrible shape because responsible parties have acted irresponsibly and I have absolute proof of that. We can begin with the Continuum of Care program: Greater Kansas City Coalition to End Homelessness. The Continuum of Care program provides funding to states, localities, and nonprofit organizations to provide permanent housing, transitional housing, supportive services, HMIS and in some cases homeless prevention. HOME-ARP funds can be used for four (4) eligible activities. 1. Production or preservation of affordable housing, 2. Tenant-based rental assistance, 3. Supportive

Services, Homeless Prevention Services, and Housing Counseling, 4. Purchase and development of non-congregate shelter. I won't go any further right now. I have much more credible information. We are in a moral crisis and we cannot continue doing things the way they have been done in the past. The team has tried working within the system, but we cannot and will not continue as people's lives are destroyed. There are others ways to get done what needs to be done to remove barriers and we are fully prepared to go to another level if that is what we have to do. We are dealing with something called generational trauma and it only gets worse if things such as homelessness is allowed to continue. If the Council has tied the City Manager's hands, that's a barrier, and I'm asking you to untie his hands and let him do what needs doing so that I don't receive another message telling me somebody has frozen to death or died out here in these streets, when it could have been prevented. This last statement is personal. The rest is business. We must remove barriers to solve these problems. What are the barriers?? I expect to attend the meeting tomorrow, Lord willing.
