Ashley Wise, General Services Department, testified on this ordinance. Giving Hope & Help INC, a non-profit, minority owned organization that provides various avenues of assistance to the community via fundraising and support. Giving Hope & Help supports domestic violence survivors, provides resources to end period poverty, empowers college bound students and inspires cancer patients. Giving Hope & Help desires to lease vacant office space in the Mohart Center to use as an office space for their daily business operations. The space consists of approximately 857.74 square feet. Rent is \$12.00/sqft = \$9,021.66 potential revenue for duration of lease term.
