Jason Waldron, Public Works Department, testified on this ordinance. This ordinance waives the prohibitions of the Code of Ordinances to allow, former employee, Ralph Davis, to consult with city staff on matters regarding the Kansas City Streetcar Authority. The Project includes nine stations, expansion of the existing vehicle maintenance facility, the purchase of six vehicles, transit signal priority and queue-jumps, intersection and sidewalk improvements, and a communications system.

Tammy Queen, Director of Finance and Steve Rattner, Loews Hotel, testified on this ordinance. The KC hotel property owner financed a portion of the loan through a term loan with NBH Bank in the original amount. This secured the contract payments. The city and the hotel owner wish to amend the catering agreement, whereby the city would make a lump sum payment for catering services during the same fifteen (15) year period in an amount not to exceed \$5,893,312.00, upfront cost. The City will (1)finance the Upfront Payment and (2) refinance the Loan in full by issuing the privately placed Series 2021E Bonds in order to achieve overall savings. The bonds will be purchased by NBH Bank. A copy of the presentation is on file in the City Clerk's Office.
